As on June 30, 2024 the company has accumulated losses of ₹ 7,475.31 lakhs and incurred Net Loss of ₹ 22.37 lakhs during the quarter ended 30th June, 2024, and as of that date the company's current liabilities exceeded its total assets by ₹6,007.61 lakhs. The company has negative net worth of ₹. 6,007.61 lakhs as on 30th June, 2024. The company is not into active business at present. This indicates that a material uncertainty exists that may cast significant doubt on the company's ability to continue as a Going Concern. The company has received continuing support from promoters as Inter Corporate Deposits for ₹. 5,949.08 lakhs, accordingly the Financial Results have been prepared on Going Concern Basis.

Our conclusion on the statement is not modified in respect of the above matter.
