नवी दिल्ली, दि. १४ (वृत्तसंस्था) : बांगलादेशात मागील काही दिवसांपासून नेकरीतील अरक्षणावरून निदर्शने सुरू आहेत. या अंदोलनामुळे देशात मोठी उलथा पालथ झाली. शेख हसीना यांनी पंतप्रधानपदाचा राजीनामा देत देशही सोडला आहे. शेख हसीना यांनी बांगलादेश सोडताच बांगला देश अंधारात बुडाला आहे, म्हणजेच देशात विजेचे संकट सुरू झाले आहे.
