**रिज़र्व बैंक - एकीकृत लोकपाल योजना (आरबी-आईओएस)**

रिज़र्व बैंक ने अपनी सभी विनियमित संस्थाओं को उनके ग्राहकों से प्राप्त शिकायतों का समाधान करने हेतु अपने स्तर पर एक व्यवस्था बनाए रखने का आदेश दिया है, जिसे विनियमित संस्थाओं का अंतर्गत शिकायत निवारण तंत्र माना जाता है।  
रिज़र्व बैंक - एकीकृत लोकपाल योजना, 2021 (आरबी-आईओएस) के माध्यम से अपनी विनियमित संस्थाओं द्वारा प्रदान की गई सेवाओं में कमियों से संबंधित ग्राहक शिकायतों के समाधान के लिए एक त्वरित और नि:मुक्त वैकल्पिक शिकायत निवारण तंत्र भी स्थापित किया है।  
बैंकों, गैर-बैंकिंग वित्तीय कंपनियों (एनबीएफसी), भूतगत प्रणाली प्रतिभागियों (पीएसपी) और साखू सूचना कंपनियों (सीआईसी) को शिकायत निवारण तंत्र के तहत विनियमित संस्थाओं के रूप में माना जाता है।
