Visit amid growing warmth between Moscow & Beijing

New Delhi, July 8

IN HIS FIRST bilateral visit after being re-elected for a third term and his first since Russia invaded Ukraine in February 2022, Prime Minister Narendra Modi landed in Moscow on Monday with a clear message that India sought to play a supportive role for a peaceful and stable region.
