SHIVAMOGGA ZOO BECKONS RARE NEW MEMBERS FROM THIRUVANANTHAPURAM

Zoo set to welcome Gharial, Rhea birds, Porcupine and Sun Conure from Trivandrum zoo; Dhole from Sri Chamarajendra Zoological Gardens also set to arrive by November end

IT will be a double delight for visitors of Tyavarekoppa Lion and Tiger Safari, (also known as Shivamogga Zoo and Safari, Tyavarekoppa) as the zoo is all set to welcome new species of animals as a part of animal exchange programme with Trivandrum zoo. The zoo is set to welcome Gharial, Rhea, Porcupine and Sun Conure from the Trivandrum zoo in the coming week. Dhole from Sri Chamarajendra Zoological Gardens, Mysuru will also be brought to Shivamogga zoo along with these, by the end of November.

Executive Director of the zoo, V M Amarakshara, told *The New Indian Express* that as a part of animal exchange programme, these inhabitants were brought and in return, a few animals will also be ex-

changed with the Trivandrum zoo. By next week, the visitors can see the newly added collection of animals.

"We didn't have any of these species so we are bringing them to the zoo. As a part of gene exchange, a Hyena will be brought as the current Hyena in the zoo is a little old. As a bloodline exchange, Hyena from out of state will be brought which will help in gene exchange," he added.

The ED said that Gharial, which is critically endangered and found in north Indian lakes, will be brought to the zoo. One male and one female will be brought. Four Rhea birds which are exotic and habitants of South America will be brought from Trivandrum zoo. Two male and two female Rhea birds will be brought, this bird is at the verge of extinction. Two porcupines, one male and one female will be brought. Sun

Conure, which is also habitat of South America, is also an endangered species. Three male and three female Sun Conures will be brought, he informed.

Amarakshara said that three female hyenas will be given to Trivandrum zoo from Shivamogga zoo as they have male hyenas. One male and female jackals will be given. One male and one female marsh crocodile will be given. One male and one female palm civet will also be given to Trivandrum zoo.

By the end of November, two dholes, one male and one female will be brought from Sri Chamarajendra Zoological Gardens, Mysuru and approval has been given for this. He said that food structure and natural enclosures to these exotic animals are arranged at the zoo. Rhea needs a grassland type of habitat and a slightly dark place, he added.

Man kills wife after she asked him to serve his lunch himself

Shivamogga: A man strangled his wife with a towel after she asked him to serve his lunch to himself at Ambigola village in Shikarpura taluk on Saturday. The suspect, identified as Manu (35), allegedly killed his wife, Gouramma (28). According to police, Gouramma, who worked at a garment factory in Shikarpura, was on a phone call when Manu returned home in the afternoon and asked her to serve him a meal. When she suggested he help himself, an argument ensued. Police said Manu strangled her during the altercation. The couple have two children who were reportedly playing outside when the incident happened. The police from Shikarpura Rural Station took Manu into custody and have started an investigation into the case.
