### Sub: Resignation from the position of Statutory Auditors of the Company

We, M/s Prasad Kumar & Co, Chartered Accountants (Firm Registration No. 008816C) were reappointed as the Statutory Auditor of the Company for the second term of further period of 5 consecutive years from the conclusion of 59<sup>th</sup> Annual General Meeting till the conclusion of the 64<sup>th</sup> Annual General Meeting of the Company to be held on the year 2027.
