The Bank has accepted the aforesaid resignation of Mr. Gobind Jain and he will cease to be the Chief Financial Officer and Key Managerial Personnel of the Bank w.e.f. close of business hours on Monday, January 20, 2025.

Mr. Arun Khurana – Whole-time Director (Executive Director) & Dy. CEO and Key Managerial Personnel of the Bank shall take additional charge as Chief Financial Officer of the Bank with effect from Tuesday, January 21, 2025, in addition to his present role and responsibilities. Mr. Gobind Jain will be relieved from the services of the Bank, only on completion of his mandatory notice period of 90 days and will be available to assist with all transition actions until close of business hours on Thursday, April 17, 2025.
