The Statements are prepared in accordance with the requirement of accounting Standards (AS) specified under Section 133 of the Companies Act 2013 read with rules Companies (Accounts) Rules, 2014 All activities of the Company revolve around the main business and as such there is no separate reportable business segment. Earning per share is calculated on weighted average of the share capital received by the Company Half Yearly EPS is not annualised. The company have approved the issuance of 41,33,720 bonus Equity Shares in the ratio of one Equity Share for every three existing fully paid up Equity Share on 13-09-2023. New Bonus Equity Shares have been considered for the computation of both Basic & Diluted EPS in accordance with para 20 of AS 20: Earning Per share issued by ICAI for all periods presented The figures for the Corresponding previous period/year have been regrouped / reclassified , wherever necessary. The Statutory Auditors have carried out the Limited Review of the above unaduited financial results of the Company. There were no exceptional and extra-ordinary items for the reporting period. The Company has raised Rs 3338.72 Lakhs by way of initial public offering (IPO) during the month of March 2024, allotment against the same was made in the month of March 2024. Amount of Rs 468.77 Lakhs was incurred towards meeting IPO expenses, Rs 343.31 lakhs was incurred for General corporate purpose and an amount of Rs. 1283.35 Lakhs was utilized as per Issue objectives (including advances) till 30th September 2024, unutilized amount of as on 30th September 2024 have been invested in Bank Deposits.
