KIRTI VYAS MURDER CASE

Burden of explaining events rests on accused, not prosecution: Court

On handing out life sentence to two employees of Bblunt, court says the victim's missing body is not detrimental to the case: evidence conclusively establishes she was with accused

The 'last seen' theory was the basis of conviction and sentencing in the case of murder of Kirti Vyas, 28, the finance manager at Bblunt salon. The court handed out life sentences to two salon employees

– Siddhesh Tamhankar, 33, and Khushi Sahjwani, 48 based on the fact that Vyas was last seen in their car on March 16, 2018. Vyas was to terminate Tamhankar's services that day.

Tamhankar and Sahjwani waited outside Vyas's house at around 8.50am when she left to board the 9.11am local train from Grant Road for Andheri. They offered to drop her and this was the last time Vyas was seen alive. Her body was untraceable despite hectic search operations at Wadala nullah and Mahul creek.

The sessions judge MG Deshpande said that "the burden of explaining the circumstances of transactions that took place inside the running car rests with both accused, not the prosecution". The court said that the missing body is not detrimental to the

The court added that "prosecution cannot be blamed for not having corpus delicti (dead body) nor the evidence led by them to that regard can extend any benefit to both accused".

6 injured in fire at Dharavi industrial compound units



Six persons suffered burn injuries after a fire broke out at an industrial compound in Dharavi on Tuesday. The blaze erupted in two structures of three and four storeys at the Ashok Mill Compound at Kala Qila at around 3.45am.

The injured persons – aged 22 to 28 years – were rushed to Sion Hospital. Two of them received 30-50% burns, and two others suffered 8-10% burns, a police official said. Another youth suffered a minor injury on his hand and was discharged after treatment. The fire was confined to wooden material, garment stock, furniture and machinery. Five fire engines and other fire fighting vehicles, including water tankers, were rushed to the spot.

The blaze, which was doused after more than four hours, probably triggered from a garment unit engaged in making frocks and other types of clothes.

Monsoon prep: 4,000 dangerous, dilapidated bldgs found in Thane

As part of its monsoon preparedness, the Thane Municipal Corporation (TMC) on Tuesday said it has identified more than 4,000 buildings in the city that are in a dangerous and dilapidated condition, and residents of some of these structures have been asked to vacate their homes. The TMC has released a list of 4,297 dangerous buildings spread across different wards in the city, an official said.

The Mumbra ward has the maximum number of 1,340 dangerous buildings, followed by Wagle Estate with 1,101, Diva with 654 and Kopri-Naupada with 433, TMC spokesperson Ravindra Man-

At least 86 buildings fall under the C-1 category, mean-

ing they are unsafe and inhabitable structures that need to be vacated and demolished, and 21 were already vacated, he said.

Chief Minister Eknath Shinde, in recent reviews, directed municipal authorities to expedite the evacuation and relocation of occupants from dangerous structures ahead of the monsoon sea-
