87th Annual General Meeting of the Members of Prime Urban Development India Limited ("The Company") held on Monday, September 30, 2024 at 11.00 a.m. through Video conferencing/Other Audio-Visual Means (OAVM).

Dear Sir,

I, S.RAMANATHAN, Chartered Accountant, having office at Door No.10, First Floor, Stanes Road-First Street, Odakkadu, Avinashi Road, Tirupur-641602 appointed by the Board of Directors of the Company at the Meeting held on August 14, 2024 to act as Scrutinizer in terms of Section 108 of the Companies Act 2013 read with Rule 20 of the Companies (Management and Administration) Rules, 2014, for the purpose of scrutinizing the process of remote e-voting and e-voting at the 87th Annual General Meeting (AGM) of the Company in respect of the Resolutions for approval at the said AGM do hereby submit my report as follows:-

1. All the Resolutions for approval at the AGM were transacted through remote e-voting and e-voting at the AGM venue for which purpose the Board of Directors of the Company engaged the services of Central Depository Services (India) Limited (CDSL).
2. Members whose names were recorded in the Register of Members of the Company or in the Register of Beneficial Owners maintained by the Depositories as on the cut-off date i.e. Monday, September 23, 2024 were entitled to cast their votes by remote e-voting or e-voting at the AGM.
3. Voting through remote e-voting commenced on Friday, September 27, 2024 at 9.00 a.m. and ended on Sunday September 29, 2024 at 5.00 p.m.



4. In respect of those Members present at the AGM who did not cast their votes by remote e-voting prior to the AGM, facility of e-voting was provided during the AGM.
5. After the conclusion of the AGM, the votes cast through e-voting at the AGM venue and remote e-voting were unblocked at 5.57 P.M. in the presence of two witnesses Mr.R.Prabhu and Mr.Unni Krishnan who are not employees of M/s.Link Intime India Private Limited or in the employment of the company in accordance with Rule 20(4)(xii) of the Companies(Management and Administration) Rules, 2014 as amended. The AGM was concluded at 11.09 A.M.


