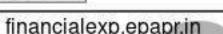

Exceptional terms consist of: During the year ended March 31, 2024, the Ministry of Information Affairs, Government of Bahrain declared the results of the frequency bidding and the Company was awarded the license to operate the Entertainment Radio Channel Frequency for a period of five years. Accordingly, the Company in June 2023 recorded a partial reversal of excess provision for onerous liabilities (net of impairment on investment) of ₹ 7.9.5 lakhs and presented the same as an Exceptional item. As of September 30, 2023, the Company carried out the recoverability assessment of loan amounting to ₹ 154.00 lakhs (given for payments in relation to license fees for Bahrain) and made an additional provision for impairment of ₹ 22.43 lakhs (after recording reversal of remaining provision towards onerous liabilities) on such loans, thereby, on a net basis, this had resulted in a write back of ₹54.52 lakhs for the year ended March 31, 2024.
