Beneficial Owners as on Friday, **31**st **January**, **2025** ("**cut-off date**") received from the Depositories and whose e-mail addresses are registered with the Company or Depository Participant /Depository / Company's Registrar & Transfer Agent (hereinafter referred to as "RTA"), as to enable them to cast their votes electronically instead of submitting the postal ballot form.
