#### RE : SCRUTINIZER'S REPORT

I, Alwyn D'Souza of Alwyn D'Souza & Co, Company Secretaries appointed as Scrutinizer by the Board of Directors of L&T Technology Services Limited for the purpose of scrutinizing the Postal Ballot e-voting process for seeking members' assent/dissent on the resolutions as specified in the Postal Notice dated November 22, 2024.

I have carried out the work as Scrutinizer from the close of the remote e-voting period i.e., 5:00 P. M. IST on Tuesday, December 24, 2024.

The Management of the Company is responsible to ensure the compliance with the requirements of the Companies Act, 2013 and Rules made thereunder, and the various circulars issued by the Ministry of Corporate Affairs, Government of India relating to Postal Ballot. My responsibility as the scrutinizer is restricted to making a scrutinizer report of the votes cast in favour / against on the resolution contained in the Postal Ballot Notice dated November 22, 2024 based on the reports generated from the e-voting system provided by the National Securities Depository Limited (NSDL), the authorized agency to provide e-voting facilities, engaged by the Company for the purpose.

I submit my report as under:

- 1. The Postal Ballot is held in compliance with the provisions of Sections 110, 108 and other applicable provisions, if any, of the Companies Act, 2013 ("the Act") read with Rules 20 and 22 of the Companies (Management and Administration) Rules, 2014, ("the Rules") (including any statutory modifications or re-enactments thereof for the time being in force as amended from time to time), read with the General Circular No. 9/2024 dated September 19, 2024 issued by the Ministry of Corporate Affairs ("MCA") (in continuation to the circulars issued earlier in this regard) ("MCA Circulars"), Regulation 44 of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015 ("Listing Regulations"), the Secretarial Standard on General Meetings issued by The Institute of Company Secretaries of India ("SS-2") and pursuant to other applicable laws, rules regulations including any statutory modification(s) or reand enactment(s) thereof, for the time being in force.
- 2. The Company has on 22<sup>nd</sup> November 2024 sent Postal Ballot Notice through electronic mode to the Members whose e-mail ids were registered with the Company, Registrar & Share Transfer Agents (RTA), Central Depository Services (India) Limited ("CDSL")/ National Securities Depository Limited (NSDL) as on Friday, November 15, 2024. The hard copy of the Postal Ballot Notice along with Postal Ballot forms and prepaid business envelope was not sent to the Members for the Postal Ballot in accordance with the requirements specified under the MCA Circulars.
- 3. The Company has on 23<sup>rd</sup> November 2024 published an advertisement in Financial Express (English) and Loksatta (Marathi).
- The e-voting facility was provided by National Securities Depository Limited ("NSDL"). The Postal Ballot e-voting period commenced on Monday, November 25, 2024 at 09:00 A.M. IST and ended on Tuesday, December 24, 2024 at 05:00 P.M. IST.

- 5. After the time fixed for closing of the e-voting i.e., 5.00 P.M. IST on Tuesday, December 24, 2024 the votes were unblocked at 5.00 P.M IST in the presence of two witnesses who are not in the employment of the Company, on the e-voting website of ('NDSL') <u>https://www.evoting.nsdl.com/</u> and a final electronic report was generated by me. The data generated was diligently scrutinized.
- **6.** The data for the purpose of verification of the number of shares was taken as on Friday, November 15, 2024 which was the relevant date (cut-off date) fixed for determining voting rights of the Members entitled to participate in the voting process.
