- 7. The Board, pursuant to Regulation 42 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, approved the closure of the Register of Members and Share Transfer Books of the Company from Tuesday, 24th September 2024 to Monday, 30th September 2024 (both days inclusive) for taking record of the Members of the Company for the purpose of the AGM.

The Board has approved the proposal, subject to the approval of the members by way of special resolution, to amend to the object clause of the Memorandum of Association of the Company to include the business of generating, accumulating, distributing and supplying green and clean energy using natural, renewable and clean sources and complimentary projects for infrastructure and real estate. The Board has also approved the proposal to adopt a new set of Memorandum of Association in line with the requirements of the new Companies Act, 2013.
- 9. The Board has approved the proposal, subject to the approval of the members by way of special resolution, to adopt a new set of Articles of Association of the Company in line with the requirements of the new Companies Act, 2013.
- 10. The Board approved the date and time for calling and holding the annual general meeting of the Company for the financial year ending March 31, 2024, and approved the notice calling the said meeting. The annual general meeting will be held on Monday, the 30th day of September 2024 at 11.00 AM (IST) through video conference and other audio-visual means ("VC") at the venue deemed to be at the registered office of the Company. The e-voting period begins on Friday, 27th September 2024 (09.00 a.m) and ends on Sunday 29th September 2024 (5.00 p.m). The Board appointed CS Ajay Suman Shrivastava, Practicing Company Secretary, as the scrutinizer for the e-voting process.
