This is with reference to our communication filed on 6th February, 2025, wherein we had informed that the Board of Directors of the Company in its meeting held on 6th February, 2025 have approved and declared an interim dividend of Rs. 0.75 (seventy five paise) per share i.e. @ 37.5% on the face value of Rs. 2/- (Rupees Two) each on the equity shares of the company for the Financial Year ended on 31 March, 2025.

As per the Income Tax Act 1961, amended by the Finance Act 2020, dividends paid or distributed by the Company, after 1st April, 2020 shall be taxable in the hands of the shareholders and the Company shall be required to deduct tax at source (TDS) at the prescribed rates from the dividend to be paid to the shareholders. Subject: Deduction of tax at source on dividend

We are pleased to inform that the Board of Directors at its meeting held on **06 February**, **2025** has recommended the payment of interim dividend of Rs. 0.75 (seventy-five paisa) per equity share i.e. at the rate of 37.50% of the face value of Rs. 2/- (Rupees Two) each for the **Financial Year ended on 31 March**, **2025**.

The interim dividend of Rs. 0.75 (seventy-five paisa) per equity share will be paid to the members whose names appear:

- As beneficial owners of the shares, as per list to be furnished by the depositories (NSDL/CDSL) in respect of the shares held in demat form on the closing hours of the business on Wednesday, 12 February 2025;
- As members on the Register of members of the company as on Wednesday, 12 February 2025.

As you may be aware, as per the Income-tax Act, 1961 (Act), as amended by the Finance Act, 2020, dividends paid or distributed by the Company after 1st April 2020, shall be taxable in the hands of the shareholders and the Company shall be required to deduct tax at source (TDS) at the prescribed rates from the dividend to be paid to shareholders. The TDS rate would vary depending on the residential status of the shareholder and the documents submitted by them and accepted by the Company. Accordingly, the net Dividend will be paid after deducting TDS as explained herein.

For resident Shareholders:

- Any resident individual shareholder is in receipt of dividend exceeding Rs. 5,000 in a financial year, entire dividend will be subject to TDS @ 10%. The rate of 10% is applicable provided the shareholder has updated his/her Permanent Account Number (PAN) with the depository/ Registrar and Transfer Agent (RTA). Otherwise the TDS rate will be 20%.
- The entire dividend will be subject to TDS for non-individual resident shareholders without any threshold limit. The tax deduction rate will be 10% provided a valid PAN is updated with the company or the depository/ RTA. Otherwise the TDS rate will be 20%.
- In case Section 206AA/206AB of Income Tax Act, 1961 got attracted then Company will withhold the tax at the rate of 20%.
- Tax at source will not be deducted in cases where a shareholder provides Form 15G (Annexure-I) (applicable to any person other than a Company or a Firm) / Form 15H (Annexure-II) (applicable to an individual above the age of 60 years), provided that the eligibility conditions are being met.

For Non-Resident Shareholders:

- Tax shall be deducted at source @ 20% (plus applicable surcharge and cess) on dividend paid to Foreign Institutional Investors ("FIIs") and Foreign Portfolio Investors ("FPIs") in view of specific provision under section 196D of the Income Tax Act 1961.
- For all non-resident shareholders, the rate of withholding tax is 20% (plus applicable surcharge and cess) as per Indian Income- tax Act, 1961. However, where a non-resident shareholder is eligible to claim the tax treaty benefit read with MLI Provision, and the tax rate provided in the respective tax treaty is beneficial to the shareholder, then the rate as per the tax treaty would be applied. In order to avail tax treaty benefits, non-resident shareholders would be required to submit ALL the below documents:
 - ✓ Tax Residency Certificate for FY 2024-25, the year in which the dividend is received (to be obtained from the Revenue / Tax authorities of the country of which the shareholder is resident)
 - ✓ Form 10F as per the format specified under Income Tax Act, 1961 (Annexure-III)
 - ✓ Self-declaration of beneficial ownership and not having a PE in India
 - ✓ Name, E-mail ID, Contact Number
 - ✓ Self-Declaration in the prescribed format. (Annexure-IV)
- Please note that the Company is not obligated to apply the beneficial DTAA rates at the time of tax deduction/withholding on the dividend amount. Application of beneficial DTAA Rate shall depend upon the completeness and satisfactory review by the Company, of the documents submitted by the non-resident shareholder. If the documents are not provided or are insufficient to apply the beneficial DTAA rates, then tax will be deducted at 20% plus applicable surcharge and cess.

- 20% for resident shareholders where Section 206AA/206AB got attracted.
- 20% for resident shareholders if copy of PAN card is not provided / not available
- Tax will be assessed on the basis of documents submitted by the non-resident shareholders
- 20% plus applicable surcharge and cess for non-resident shareholders in case the aforementioned documents are not submitted
- Lower/ NIL TDS on submission of self-attested copy of the certificates as referred above / certificate issued under section 197 of the Act.
- 20% plus applicable surcharge and cess for FIIs and FPIs under section 196D of the Act

- ii. To enable us to determine the appropriate TDS / withholding tax rate applicable, we request you to provide the above details and documents on or before close of business hours on 12th February, 2025.

The documents such as Form 15G/ 15H, documents under section 196, 197A, FPI Registration Certificate, Tax Residency Certificate, Lower Tax certificate etc. can also be uploaded on the link https://einward.alankit.com/ on or before 12th February, 2025 to enable the Company to determine the appropriate withholding tax rate applicable. In case where copy of documents (such as, PAN card, Registration certificate, etc.) is provided, the copy should be self-attested by the Shareholder or its authorized signatory.

- i. In terms of Rule 37BA of Income Tax Rules 1962, if dividend income on which tax has been deducted at source is assessable in the hands of a person other than the dedicatee, then such a dedicatee should file a declaration with Company in the manner prescribed by the Rules on or before 12th February, 2025. The Company will not accept any declarations referred to Rule 37BA of Income Tax Rules, 1962 after the aforesaid date.
- ii. In case tax on dividend is deducted at a higher rate in the absence of receipt of the aforementioned details/ documents, you would still have the option of claiming refund of the excess tax paid at the time of filing your income tax return by consulting your tax advisor. No claim shall lie against the Company for such taxes deducted. Shareholders will be able to see the credit of TDS in Form 26AS, which can be downloaded from their e-filing account at https://incometaxindiaefiling.gov.in.
- iii. Shareholders holding shares under multiple accounts under different status / category and single PAN, may note that, higher of the tax as applicable to the status in which shares held under a PAN will be considered on their entire holding in different accounts.
- iv. In the event of any income tax demand (including interest, penalty, etc.) arising from any misrepresentation, inaccuracy or omission of information provided / to be provided by the Shareholder(s), such Shareholder(s) will be responsible to indemnify the Company and also, provide the Company with all information / documents and co-operation in any appellate proceedings.
- v. Shareholders are requested to ensure that their bank account details in their respective demat accounts/ folios are updated, to enable the Company to make timely credit of dividend in their bank accounts.

Your co-operation in this regard is solicited.

ATTENTION TO ALL THE SHAREHOLDERS
