Pursuant to the provisions of Regulation 30 of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015, this is to inform you that the Central Bureau of Investigation (CBI), Special Judge (PC Act) CBI, Coal Block Cases – 01, New Delhi, vide its order dated 9th December, 2024, has convicted Shri Ramesh Jayaswal, Promoter and Managing Director of JNIL, along with other person(s)/Company which are not connected to JNIL, in respect of allocation of Coal Blocks (Brinda, Sisai and Meral) in the State of Jharkhand in favour of M/s Abhijeet Infrastructure Private Limited, in which Shri Ramesh Jayaswal was Director till 31st December, 2001 and Authorised Signatory subsequently.
