- ii. Date and time of commencement of "Remote e-voting": **Friday, 27th September, 2024 at 9:00 A.M.**
- iii. Date and time of end of "Remote e-voting" : **Sunday, 29th September, 2024 at 5:00 P.M.**(same day)
- iv. Cut-off date for E-Voting : **Monday, 23rd day of September, 2024**
- v. Remote E-voting shall not be allowed beyond **5:00 P.M. on Sunday, 29th September, 2024.**
- vi. Any person, who acquires shares of the Company and become member of the Company after dispatch of the notice and holding shares as of the cut-off date i.e. **23rd day of September, 2024**, may obtain the login ID and password by sending a request at helpdesk.evoting@cdslindia.com or ssl_1994@yahoo.co.in. However, if you are already registered with CDSL for remote e-voting then you can use your existing user ID and password for casting your vote. - vii. The members who have casted their vote by remote e-voting prior to the AGM may also attend the AGM but shall not be entitled to cast their vote again.

The facility for venue voting shall be made available at the meeting and the members who have not casted their vote by remote e-voting shall be able to attend the AGM and vote by use of Venue Voting.
