इंदौर। महिला थाना पुलिस ने एक युवक और उसके परिवार वालों के खिलाफ दहेज प्रताड़ना का मुकदमा दर्ज किया है। आरोपी की पती ने आरोप लगाया है कि उससे दहेज में ऑटो रिक्शा और 10 लाख रुपए की मांग की जा रही है, महिला थाने में भागीरथपुरा निवासी एक युवती की शिकायत पर उसके पति सौरभ गौड और सास किर्□ा गौड सहित ससुर राधा कृष्णा गौड़ के खिलाफ मुकदमा दर्ज किया गया है। पीड़िता ने पुलिस को बताया कि शादी को 2 साल बीत गए हैं, आरोपी पति और सास ससुर लगातार दहेज में 10 लाख रुपए की मांग को लेकर उसे परेशान कर रहे थे । पति ऑटो भी चाह रहा था। इन्होंने उसे कई बार मारा पीटा जब उनकी मांग पूरी नहीं हुई तो मारपीट कर घर से निकाल दिया।

स्कूल प्राचार्य सीमा जैन शिकायत पर पुलिस ने खजराना की प्राइवेट महिला टीचर जैनब, उसका पति मुस्तफा शेख, एग्जाम देने आए नाबालिग छात्र का भाई जुनैद खान, दूसरे की जगह परीक्षा देने बैठी नाबालिंग छात्रा और नाबालिंग छात्र पर केस दर्ज किया गया है। जिस प्राइवेट टीचर को मुख्य आरोपी बनाया है, वह खजराना क्षेत्र में प्राइवेट स्कुल में पढाती है।

माध्यमिक शिक्षा मंडल की 10वीं-12वीं की परीक्षा में फेल हुए स्टूडेंट्स के लिए 'रुक जाना नहीं योजना' में 20 मई से परीक्षा आयोजित की जा रही थी। शक्रवार को परीक्षा केंद्र शारदा कन्या उमावि में 10वीं में फेल हुए स्टूडेंट्स का विज्ञान का पेपर था। परीक्षा दोपहर 2 से शाम 5 बजे तक चली। इसी दौरान फर्जी परीक्षार्थी पकडे गए। यहां पता चला कि एक छात्रा नकाब और एक छात्र मास्क लगाकर एक्जाम दे रहा है। इस बीच गर्मी लगने पर उस छात्रा ने नकाब हटाकर पसीना पोंछने की कोशिश की तो चेहरा देखकर पर्यवेक्षक को शक हुआ। उसने फोटो से छात्रा का मिलान किया। फिर

साइन करवाकर दोबारा तस्दीक की तो कन्फर्म हो गया कि ये फर्जी छात्रा है। लेकिन हंगामा न हो इसलिए बीच एक्जाम में छात्रा को रोका नहीं और उसे एक्जाम देने दी गई। इसी तरह एक अन्य छात्र ने भी मास्क हटाया तो वह भी इसी तरह ट्रेस हो गया। एक्जाम के बाद शुक्रवार शाम को प्रिंसिपल ने मल्हारगंज थाने पहुंच रिपोर्ट दर्ज करवा दी है। इसमें टीचिंग स्टाफ समेत 5 लोग शामिल

जिसने फार्म भरा है। पूछताछ में छात्रा ने बता दिया कि उसे सर और मैडम लेकर आए हैं। इसी तरह मास्क लगाकर एक्जाम देने वाला छात्र भी पकडा गया है। बच्चों को एक्जाम दिलाने लाने वाले सर-मैडम और एक अन्य साथी सहित 5 लोगों पर केस दर्ज करवाया है। ये कौन लोग है जो इस तरह एक्जाम दिलवा रहे थे, हमें नहीं पता।

About this leader it is said though he may neither be sent to the Upper House nor made president of the party's state president, yet he is set to get an important position after the Lok Sabha election.

Praying for rival's win

leader of the BJP who has set his eyes on a seat of the Rajya Sabha is praying for the victory of a Congress leader. Because the Congress leader is a Rajya Sabha member, if he wins the election, the seat will fall vacant; but it will go to the BJP. He is praying



for the victory of his rival, so that he may have an opportunity to go to the Upper House. Similarly, another RS seat may fall vacant if a member of the BJP in the Upper House, also contesting the parliaelection, mentary wins his seat. The politician thinks if there is a by-election only for one seat, his chances for going to

the Upper House are dim. If both seats fall vacant, then only he has an opportunity to hit the jackpot. This politician did not canvass for the Congress candidate, but since the day he came to know that if the rival contender won the seat it would go to the BJP, he has begun to pray for the opponent's victory

renowned Bollywood actor, fielded by the ruling party from a constituency in Himachal Pradesh to fight the 2024 parliamentary election, was likely to throw down the gauntlet from the Guna constituency in Madhya Pradesh to the then Congress's big cheese Jyotiraditya Scindia in 2019. Mine collapse kills 5 in Kenya

Nairobi: An illegal gold mine collapsed in northern Kenya, leaving at least five miners dead, police said Saturday. The collapse of the Hillo mine in the Dabel area on Friday was attributed to a landslide. Marsabit County Police Commander Patrick Mwakio said the miners died on the spot after the debris covered them. No other miners have been found and it was not clear if anyone else was missing in the collapse. Interior Minister Kithure Kindiki in March had declared the area as disturbed and had subsequently banned mining activities in the area after a mining dispute led to the deaths of seven people.

Pro, anti-Iran protestors clash

London: British police say four people were hurt and one was arrested when supporters of Iran's authorities clashed with anti-government protesters at a London event marking the death of President Ebrahim Raisi. Protesters had gathered outside the venue in the west London area of Wembley and clashes broke out, police said. One person was arrested on suspicion of violent disorder Four people were treated by paramedics for injuries that are not thought to be lifethreatening or life-changing. Police said that detectives would examine social media footage and other evidence to see whether more offenses had been committed.

Baloch activists lambast Pakistan

Oslo: Prominent Baloch leader, Mahrang Baloch, in a discussion with the Norway chapter of Pen International, highlighted the issue of enforced disappearances and extrajudicial killings in Balochistan. The Baloch leader stated that during the last two decades, in the name of counter-insurgency operations and peace, a large number of people have been forcibly disappeared by Pakistani forces. She further stressed that these people have been detained in detention centres, and tortured and their families didn't know about their whereabouts

Monkey menace in Thai town

Thailand: The Thai town of Lopburi, plagued by several cases of monkey-human conflict launched an offensive on Friday, using trickery and ripe tropical fruit.. The first stage of the plan, instituted the animals' favorite food The captured monkeys will then be relocated elsewhere There are thought to be around 2,500 monkeys running around the town. The effort will go on for five days this month, then is likely to be repeated. Some of the monkeys will be left free to maintain Lopburi's image as Thailand's monkey town.

Heavy rains return to Brazil

PORTO ALEGRE: Heavy rains once again hit Brazil's southernmost state on Thursday, ruining days-long clean-up efforts and flooding areas which had previously been untouched in Rio Grande do Sul's capital city of Porto Alegre. Record flooding over the past month killed 163 people, and over 600,000 were displaced. Another 64 people are still missing. Rains had lightened up over the past few days, with stores beginning to onen and residents working to rebuild. But the rains returned Thursday morning. In a span of 12 hours, parts of Porto Alegre received more rains than they did in a whole month, according to data from the country's national meteorological institute.

'ICJ ruling is outrageous'

Israel says it has no choice but to attack Rafah to root out the last of Hamas fighters

There was no let up in Israeli military strikes on Friday even as the UN's top court, International Court of Justice (ICJ), ordered Israel to halt its military offensive in the southern Gaza city of Rafah.

Israel called the order "outrageous, morally repugnant and disgusting", adding that the accusations it is committing genocide in Gaza "are false", reported Al Jazeera. Israel Earlier

signalled it would ignore any ruling to halt its offensive by the court, which has no enforcement powers. It said it has no choice but to attack Rafah to root out the last battalions of Hamas fighters it believes are sheltering there.

Israel said its military offensive in Gaza was in line with international law. "Israel has not and will not carry out military operations in the Rafah area that create living conditions that could cause the destruction of the Palestinian civilian population, in whole or in part," Na-tional Security Adviser Tzachi Hanegbi said in a joint statement with the foreign ministry

War cabinet minister Benny Gantz said Israel would continue its offensive "wherever and whenever necessary including in Rafah"

In New York, Palestinian ambassador to the UN, Riyad Mansour, hailed the ruling and called for Israel to abide by it. "We expect that resolutions of the ICJ will be implemented without hesitation,' he said. "That's mandatory. And Israel is a party to the convention.

Hamas deputy commander killed in airstrike: IDF

IANS / TEL AVIV

deputy commander of Hamas has been killed in an airstrike in central Gaza Strip, the Israel Defense Forces (IDF) have announced.

The IDF in a statement on Friday night identified the killed Hamas commander as Tziad al-Din al-Sharfa. The statement said he was killed in an Israel air attack in central Gaza.

The Israeli Army said the assassination of the senior Hamas leader was conducted through a joint operation between IDF, Shin Bet and Military Intelligence.

The 99 Infantry Division of the IDF led the operation and coordinated the attack on al-Sharafa, considered a key operative of Hamas in the Gaza Strip.

The IDF is now specifically focusing on senior leaders of Hamas and is working on specific inputs from Shin Bet and Israel Military intelligence on the movement of senior Hamas group leaders.

The IDF also said that it had assassinated Yusuf al-Shobaki who was heading the Industrial Security department of the Hamas militant group in Gaza.

Meanwhile, Israeli activists battled over Gazahound aid convovs in an attempt to disrupt the aid. With aid lorries entering Gaza at the main Kerem Shalom crossing, the battle is now between rival groups of activists doing their best to block and those trying to protect aid convoys.

US TO GIVE \$275 MN AID PACKAGE TO UKRAINE

The US will provide a new \$275 million military aid package for Ukraine to help the beleaguered country repel Russia's assault on Kharkiv, U.S. Secretary of State Antony Blinken said in a statement Friday.

The package contains urgently needed capabilities including ammunition for HI-MARS, 155mm and 105mm artillery rounds, missiles, anti-armor systems and precision aerial munitions, the State Department said in a statement.

"Assistance from previous packages has already made it to the front lines, and we will move this new assistance as quickly as possible so the Ukrainian military can use it to defend their territory and protect the Ukrainian people," the statement said.

Meanwhile, a report said that finance chiefs from the Group of Seven industrial democracies and central bankers will be meeting Stresa in Italy on Saturday to explore ways of using frozen Russian assets to help Ukraine, which is struggling to contain a Russian offensive in the north and the east

The G7 and its allies froze some \$300 billion of Russian assets shortly after Moscow invaded its neighbour in February 2022, in order to hamper the Russian onslaught.

"We are making progress in our discussions on potential avenues to bring forward the extraordinary profits stemming from immobilized Russian sovereign assets to the benefit of Ukraine,", according to a statement issued by the forum. G7 negotiators have dis-

cussed for weeks how to best exploit the assets, such as major currencies, which are mostly held in European-based depositories.

The US has been pushing

its G7 partners to back a loan that could provide Kyiv with as much as \$50 billion in the near term.



Taken back embattled areas: Zelenskyy

Ukrainian forces have secured "combat control" of areas where Russian troops entered the northeastern Kharkiv region earlier this month, Ukrainian President Volodymyr Zelenskyy has claimed.

"Our soldiers have now managed to take combat control of the border area where the Russian occupiers entered," Zelenskyy said in his nightly video address on Friday evening. Zelenskyy's comments ap-

peared to be at odds with those of Russian officials.

Viktor Vodolatskiy, a member of Russia's lower house of parliament, said Russian forces now controlled more than half of the town of Vovchansk, three miles (five kilometers) inside the border, Russian state news agency Tass reported on Friday.

Vovchansk has been a flashpoint since Russia launched an offensive in the Kharkiv region on May 10. Vodolatskiy was also quot

ed as saying that, once Vovchansk was secured Russian forces would target the cities of Sloviansk, Kramatorsk and Pokrovsk in the neighboring Donetsk region. No independent confirmation of the claims was immediately possible.

Russia's Kharkiv push appears to be a coordinated new offensive that includes testing Ukrainian defenses in the Donetsk region further south — where Russia's Defense Ministry said Saturday that its forces had taken over the village of Arkhanhelske

 while also launching incursions in the northern Chernihiv Sumy and regions. Russian President Vladimir Putin has said the Kremlin's army attempting to create a "buffer zone" in the Kharkiv region to prevent Ukrainian cross-

border attacks.




