There is no pending regulatory action against us.

We along with the persons related to us shall continue to comply with the conditions mentioned at sub-clauses (i), (ii) and (iii) of clause (b) of Regulation 31A(3) of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 at all times from the date of re-classification, failing which, we shall be reclassified as persons belonging to the promoter and promoter group of the Company.

We along with persons related to us shall comply with the conditions mentioned in the of sub-clauses (iv) and (v) of clause (b) of Regulation 31 A(3) of SEBI (Listing Obligations and Disclosure Requirements), Regulations, 2015 for a period of not less than three years & from the date of reclassification, failing which, we shall be reclassified as person belonging to promoter and promoter group of the company.
