Dear Sir,

I, **Dinesh Kumar Deora**, Company Secretary in practice (Membership No. FCS 5683 COP No. 4119) was appointed as Scrutinizer by the Board of Directors of **CAPRI GLOBAL CAPITAL LIMITED** ("the Company") for the purpose of scrutinizing the Postal Ballot conducted by way of remote e-voting process ("e-voting") in a fair and transparent manner on the Resolution contained in the Postal Ballot Notice dated June 07,2024 ("Notice") issued in accordance with the provisions of Section 110 read with Section 108 and other applicable provisions, if any, of the Companies Act, 2013 (the "Act"), Rules 20 and 22 of the Companies (Management and Administration) Rules, 2014 (including any statutory modification(s) or re-enactment thereof for the time being in force), Regulation 44 of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015 (SEBI LODR Regulations), Secretarial Standard on General Meetings (SS-2) to the extent applicable.

- 1.1 The postal ballot is conducted in accordance with the guidelines prescribed by the Ministry of Corporate Affairs ('MCA') for holding general meetings/conducting postal ballot process through e-voting vide General Circular Nos. 14/2020 dated April 8, 2020, 17/2020 dated April 13, 2020, 22/2020 dated June 15, 2020, 33/2020 dated September 28, 2020, 39/2020 dated December 31, 2020, 10/2021 dated June 23, 2021, 20/2021 dated December 8, 2021, 3/2022 dated May 5, 2022,11/2022 dated December 28, 2022 and 09/2023 dated September 25, 2023 (collectively the 'MCA Circulars'), to transact the special business as set out hereunder by passing Special Resolution by the Members of Capri Global Capital Limited (the "Company") through Postal Ballot via remote e-voting.
- 1.2 The Company **completed** the **dispatching** / **e-mailing** of the Postal Ballot Notice **on June 14, 2024** to its members whose name(s) appeared on the Register of Members / List of Beneficiaries as on **Friday, June 07, 2024** maintained by the depositories viz. National Securities Depository Limited (NSDL) and Central Depository Services (India) Limited (CDSL) and who have registered their email address with the Company/Depositories.
- 1.3 In compliance with the provisions of Sections 108 and 110 and other applicable provisions of the Act, read with the Companies (Management and Administration) Rules, 2014 and Regulation 44 of the SEBI Listing Regulations as amended from time to time, read with SEBI circular no. SEBI/HO/CFD/CMD/CIR/P/2020/242 dated December 9, 2020 on remote e-voting, the company had engaged the services of NSDL for facilitating the

- 1.4 **Total No. of votes based on Paid Up Capital** of the Company as on **June 07, 2024** were 82,49,39,972.
- 1.5 **Public Announcement** with respect to completion of dispatch of Postal ballot Notice in Two (2) newspapers were made on June 15, 2024 in Business Standard in English and Mumbai Lakshadeep (Mumbai Edition) in Marathi.
- 1.6 The remote e-voting commenced on Saturday, June 15, 2024 at 9.00 a.m. (IST) and ended on Sunday, July 14, 2024 at 5.00 p.m. (IST).
- 1.7 **Particulars of remote e-voting** of the Postal Ballot through e-voting process from the members **have been maintained electronically** to record the assent or dissent received.
- 1.8 The **e-voting was blocked at 5.01 p.m. on Sunday, July 14, 2024** and the e-voting summary statement was thereafter downloaded from the NSDLs e-voting website on Sunday, July 14,2024 at 5.02 p.m. in presence of two witness not in employment of the Company.
- 1.9 The Management of the Company is responsible to ensure compliance with the requirements of the Act, the Rules and the MCA Circulars relating to remote evoting on the Resolutions contained in the notice of Postal Ballot.
- 1.10 My responsibility as scrutinizer for the voting through remote e-voting is restricted to making a Scrutinizer's Report of the votes cast in favour or against the said resolutions.
