# <u>Summary of the proceedings of the Postal Ballot of Gandhi Special Tubes Limited, passed by the Shareholders on 28 November 2024</u>

Pursuant to the provisions of Section 110 of the Companies Act, 2013 read with the Companies (Management and Administration) Rules, 2014 and Regulation 44 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, the Company had issued a Postal Ballot Notice dated 28 October 2024 to obtain approval of shareholders through Postal Ballot by providing remote e-voting facility only for

- 1. Appointment of Mrs. Ritika Shah (DIN: 10723406) as a Woman Independent Director of the Company
- 2. To make investments, give loans, guarantees and security in excess of limits specified under section 186 of the Companies Act, 2013.

The Board of Directors had engaged services of KFin Technologies Limited ("Kfin Tech") to provide evoting facility to all the members as on cut-off date i,e. Friday 25 October 2024. The evoting period commenced on Wednesday, 30 October 2024, at 9:00 A.M. (IST) and ended on Thursday, 28 November 2024 at 5:00 P.M. (IST)

The Board of Directors had appointed Mr. Nrupang Dholakia, Practicing Company Secretary, Designated Partner of Dholakia & Associates LLP, to act as the scrutinizer, for conducting the postal ballot process, in a fair and transparent manner.

Pursuant to the applicable General Circulars issued by the Ministry of Corporate Affairs for conduct of postal ballot, the Postal Ballot Notice and instructions for e-voting were sent only through electronic mode to those Members whose email address were registered with the Company / depository participant(s).

The intimation about completion of dispatch of the Notice of Postal Ballot /e-Voting and the last date for casting of votes by shareholders was also intimated to the members by way of publication of advertisement in the newspapers namely, Navshakti (Marathi Language) and Free Press Journal (English Language) on 30 October 2024

Members were advised to carefully read the instructions before casting their votes. The postal ballot was conducted only through remote e-voting system . The Scrutinizer after scrutiny of all votes received within the scheduled time has submitted his report on 29 November 2024. The results of the Postal Ballot as required under Regulation 44 of The SEBI (LODR) Regulations, 2015 are enclosed herewith.

- 1. Dholakia & Associates LLP, Company Secretaries ("firm") were appointed as the scrutinizer by **GANDHI SPECIAL TUBES LIMITED** ("Company") to scrutinize the postal ballot voting process (voting by e-voting/remote e-voting) in connection with the subject matter.
- 2. I, CS Nrupang B. Dholakia, Managing Partner of the firm, submit my report as under:

  - 2.3 An intimation was published in Free Press Journal (English) and Navshakti (Marathi) on October 30, 2024 post the completion of dispatch of Postal Ballot Notice to the members specifying the matters as required under Rule 22 of the Companies (Management and Administration) Rules, 2014.
  - 2.4 The postal ballot was conducted only through remote e-voting system which was provided by Kfin Technologies Limited pursuant to the above referred circulars, hence, postal ballot forms were not required to be sent by the Company.
