The Company have supplied Agricultural Equipment's worth Rs. 3,48,60,310/-.</p> <p>Direct delivery was made to the defendant, out of which the defendant had paid a total of Rs. 2,85,14,740 /- and leaving the balance of Rs. 63,45,570 /- as due.</p> <p>That as per the business practice, payment have to be made within a period of 45 days from the date of supply of the goods, but the defendant did not make full payment to the plaintiff and without any basis, the plaintiff's amount of Rs. 63,45,570/- along with Interest @ of 3 times of the RBI rate which remained outstanding till date.</p> <p>The Company (Plaintiff) had made various correspondences with the directors/ authorized representatives of Khedut Agro Engineering Private Limited (The Defendant) for requesting to release the overdue payments but even after making all the efforts, the Defendant failed to make payment of the outstanding amount.</p>
