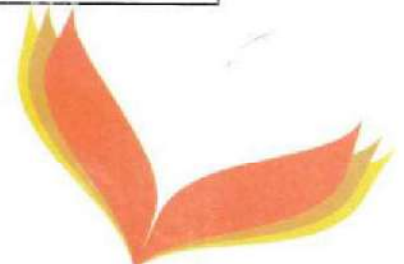

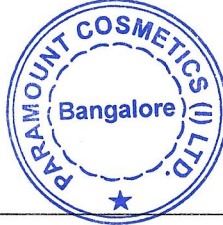

2. The Audit Committee has reviewed, and the Board of Directors has approved the above results and its release at their respective meetings held on 23rd May 2024. The Statutory Auditors of the Company have issued audit report with unmodified opinion on the above results.
3. The requirement of Ind AS 108 "Segment Reporting" is not applicable to the Company as it is engaged in single business segment.
4. Previous period's figures have been regrouped/re-classified wherever necessary to make the same comparable.
5. The company is not having any subsidiary, associate, or joint venture therefore, it has prepared only standalone results.

During the year the balance of Loans and Advances to Related parties has been converted into two parts through an agreement & board resolution Rs.1.25 crore as interest free security deposit against building (owned by the said related party) taken by the company for office use and Rs.4.5 crore towards business deposit for selling & distribution in specified territories which carries rate of interest at 9% p.a. Further out of 4.5 crore deposit Rs.3.38 crore has been adjusted against vendor balance of current year purchases from the said related party.



Report on the Audit of the financial statements.

Opinion

We have audited the accompanying financial statements of M/s. PARAMOUNT COSMETICS (INDIA) LIMITED ("the Company"), which comprise the Balance Sheet as at March 31, 2024, the Statement of Profit and Loss (including Other Comprehensive Income), the Statement of Changes in Equity and the Statement of Cash Flows for the year then ended, notes to the financial statements including material accounting policy information and other explanatory information (hereinafter referred to as the "financial statements").


