Sub: Rejection letter for Reclassification of Shareholders under Regulation 31A of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015.

Dear Sir/Madam,

We refer to your application dated March 02, 2024, seeking Reclassification of Promoter Shareholders under the provisions of Regulation 31A of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015.

In this regard, it is observed that-

- 1. The company has applied for reclassification of 1 promotor, i.e. Mr. Manan Narang (total holding 0.00%) out of 11 promoters.
- 2. Exchange observed that the outgoing promoter Mr. Manan Narang have relation with Naveen Narang (holding 24.75%) (Brother of Manan Narang) who is the continuing promoter and the Chairman, CEO and Managing Director of the company. Hence, the Company is not in compliance with the provisions of Regulation 31A(3)(b)(i) which inter alia provides that -"the promoter(s) seeking re-classification and persons related to the promoter(s) seeking re-

classification shall not

- together, hold more than ten percent of the total voting rights in the listed (i) entity"
- 3. In view of the aforesaid, since the application filed by the company is not in compliance with Regulation 31A(3)(b) of SEBI (LODR) Regulations 2015.

In view of the above circumstances, the Company's application for Reclassification of promoter is rejected.
