Sub: Outcome of Circular Resolution passed by the Nomination, Remuneration and Compensation Committee

1. Approved allotment of 77,450 Equity shares of Rs.10 each under ESOP-2007 scheme to the eligible employees of the Company on exercise of stock options vested in them.
