- The company's Board of Directors approved Mr. Dinesh Nandwana as Chairman & Managing Director (CMD) on August 12, 2024, following the recommendation of the Nomination and Remuneration Committee. This appointment and his exceptional leadership and vision align the company's business strategy with its future growth roadmap.
