- We have reviewed the accompanying Statement of Unaudited Financial Results of The Ruby Mills Limited ('the Company') for the quarter ended June 30, 2024, ("the Statement") together with the notes attached herewith, being submitted by the Company pursuant to the requirements of Regulation 33 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, as amended ('Listing Regulations').

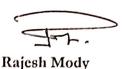
