## Sub: Allotment of Warrants to the promoters and members of the Promoter group by way of **Preferential Issue**

Pursuant to Regulation 30 of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015 and Shareholders' approval dated September 27, 2024 and In-Principle approval letter No. LOD/PREF/AM/FIP/1115/2024-25 issued the BSE Limited and Letter Ref: NSE/LIST/43828 issued by the National Stock Exchange of India Limited, both dated October 11, 2024, we would like to inform you that the Board of Directors of the Company at its meeting held today, has approved the allotment of 13333789 warrants at an issue price of INR 369/-(Rupees Three Hundred Sixty Nine only) ("Warrants Issue Price"), aggregating up to Rs. 492,01,68,141/- (Rupees Four Hundred Ninety-Two Crore One Lakh Sixty-Eight Thousand One Hundred Forty-One Only) on a preferential basis by way of a private placement, to the promoters and members of the Promoter group.

The Company has received Rs. 188/- per warrant i.e. 50.9485% of the Warrants Issue price, aggregating to Rs. 250,67,52,332/- as per the details set forth below:

After conversion of all 13333789 warrants by the Company, the shareholding of promotors and members of the promotor group will be 41.71% of total equity share of the Company on a fully diluted basis.
