With reference to the captioned subject, we would like to inform you that the Company has received an order passed by Deputy Commissioner of Customs, Bangalore, demanding a duty of Rs. 2,01,42,626/- (Rupees Two Crore One Lakh Forty-Two Thousand Six Hundred and Twenty Six only) along with applicable interest in relation to non-compliance with the terms of the Customs Notification and Bond under Section 28AA of the Customs Act, 1962 and imposing a penalty of Rs. 50,00,000/- (Rupees Fifty Lakh only) in relation to default of conditions of Customs Notifications and Bond covered in the 6 Show cause Notices under Section 112(a) of the Customs Act, 1962. However we would like to emphasize that Company has fulfilled the required export obligations.

The Order dated July 30, 2024 has been issued and received by the Company on August 21, 2024.

Based on the Company's assessment, an appeal will be filed against the said order and the Company is hopeful of a favourable outcome at the appellate level.

The details of the above order, as required under Clause 20 of Para A of Part A of Schedule III of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 is enclosed as Annexure I.
