# Prachanda will not quit

Embattled Nepal Prime Minister Pushpa Kamal Dahal 'Prachanda' has decided not to resign from the post despite an agreement reached between the country's largest parties --Nepali Congress and CPN-UML -- to form a new coalition government.

In a meeting of the Communist Party of Nepal (Maoist Centre) office-bearers held in Baluwatar on Tuesday, Prime Minister Prachanda said he would rather face a vote of confidence in Parliament than resign from the post, party Secretary Ganesh Shah told

"The Prime Minister has decided to seek a vote of confidence," said Shah.

Prachanda, 69, has won three votes of confidence in Parliament during his oneand-a-half-year term.

The development came after Nepali Congress President Sher Bahadur Deuba and the Communist Party of Nepal-Unified Marxist Leninist (CPN-UML) inked a mid-

Joe Biden has described as a "dangerous precedent" a Supreme Court ruling giving former President Donald Trump partial immunity from criminal prosecution.

The current US president said the judgement undermined the "rule of law" and was "a terrible disservice" to Americans.

Earlier, Trump hailed the court's decision as a "big win" for democracy.

The justices found on Monday that a president had immunity for "official acts" but was not immune for "unofficial acts", and referred the matter back to a trial judge.

The judgement will further delay the criminal case against Trump for allegedly trying to subvert the 2020 election result that gave victory to Mr Biden.

A Pakistani anti-corruption court on Tuesday granted pre-arrest bail to jailed exprime minister Imran Khan's wife and former first lady Bushra Bibi in a case of alleged corruption. Khan and Bibi face charges of causing a loss of about Rs50 billion to the national exchequer in the Al-Qadir Trust corruption case. Judge Muhammad Ali Warraich presided over the hearing at Adiala Jail in Rawalpindi and approved her pre-arrest bail plea. However, despite the grant of bail, Bushra, 49, will remain behind bars due to a conviction in the illegal marriage case.
