MOSCOW

Russia's southern region of Dagestan held the first of three days of mourning on Monday following a rampage by Islamic militants who killed 19 people, most of them police. and attacked houses of worship in apparently coordinated assaults in two cities.

Sunday's violence was the latest that officials blamed on Islamic extremists in the predominantly Muslim region in the North Caucasus, as well as the deadliest in Russia since March, when gunmen opened fire at a concert in suburban Moscow, killing 145 people.

The March attack was claimed by an affiliate of the Islamic State group. but no one has stepped forward to take responsibility for Sunday's attacks in Dagestan's regional capital of Makhachkala and nearby Derbent, both adjacent to the Caspian Sea.

Dagestan Gov. Sergei Melikov blamed members of Islamic "sleeper cells" directed from abroad, but didn't give any other details. He said in a video statement that the assailants aimed at "sowing panic and fear," and attempted to

LONDON: UK government officials attempted to suppress criticism of the United Arab Emirates and its alleged role in supplying arms to a notorious militia waging a campaign of ethnic cleansing in Sudan, sources told the Guardian.

Claims that Foreign Office officials put pressure on African diplomats to avoid criticising the UAE over its alleged military support for Sudan's Rapid Support Forces (RSF) will intensify scrutiny of the UK's relationship with the UAE.

The RSF, a paramilitary group accused of carrying out crimes against humanity by rights groups, is besieging the El Fasher in Darfur, Sudan. Fighters have encircled the city, amid evidence they are targeting and murdering civilians based on their ethnicity.
