	Brief Description of Litigation	By its order dated 7 <sup>th</sup> February, 2025, the Hon'ble Bombay High Court has dismissed Tilaknagar Industries' (TI's) Notice of Motion No. 1287 of 2010 in Counter Claim No. 6 of 2010 in Commercial IP Suit No. 2 of 2009 against Herman Jansen Beverages Nederland B.V. & Ors. inter alia seeking injunction against them from manufacturing and/or bottling and/or marketing and/or trading in and/or otherwise dealing in alcoholic products bearing the trade mark 'MANSION HOUSE' and/or 'SAVOY CLUB' so as to pass off their business and goods as and for those of TI.  The Hon'ble Bombay High Court has also allowed Allied Blenders & Distillers Pvt. Ltd.'s (ABD's) Interim Application (L) No. 16999 of 2023 in the above Counter Claim granting leave to ABD to introduce products bearing the mark 'MANSION HOUSE' in the State of West Bengal. However, upon application made by the Counsel on behalf of TI for stay of the said order, the Court directed that the said order granting leave to ABD shall not come into effect for a period of four weeks and during that period ABD shall not introduce any product with the trade mark 'MANSION HOUSE' into the market, within which period TI can file an Appeal from the date of the said order.
