Sub: Consolidated Scrutinizer's Report on remote e-voting and the voting through ballot during the Annual General Meeting conducted pursuant to the provisions of Section 108 of the Companies Act, 2013 read with Rule 20 of The Companies (Management and Administration) Rules, 2014 for the 40th Annual General Meeting of Ventura Guaranty Limited held on Monday, 30th September, 2024 at 10.00 A.M. (IST)

We, Roy Jacob & Co, Company Secretaries having our office at 207, Anjani Complex, Periera Hill Road, Nr. WEH Metro Station, Andheri-East, Mumbai-400099, appointed as Scrutinizer of Ventura Guaranty Limited for the purpose of scrutinizing remote E-Voting process ('E-Voting') as well as to scrutinize the physical Ballot Papers received from the members at the venue of the Annual General Meeting held on 30th September 2024 pursuant to Sections 108 and 109 of the Companies Act, 2013 in a fair and transparent manner and ascertaining the e-voting pattern carried out as per the provisions of the Companies Act, 2013 and Rule 20 of the Companies (Management and Administration) Rules, 2014 on the below mentioned resolutions, submit my report as under:

- 1. The Company has appointed Bigshare Services Pvt Ltd as the Service Provider, for the purpose of extending the facility of remote E-Voting to the Members of the Company.
- 2. The e-voting remained open from 9.00 a.m.(IST) on 27th September, 2024 to 5.00 p.m.(IST) on 29th September, 2024.
- 3. The shareholders holding shares as on the "cut off" date i.e 22nd September, 2024 were entitled to vote on the proposed resolutions .(As per Notice)
- 4. The votes were unblocked on 01st October 2024 around 11.50 A.M in the presence of two witnesses and thereafter the details containing, inter alia, list of equity shareholders, who voted "For" and "Against", were downloaded from the e-voting website of Service provider.

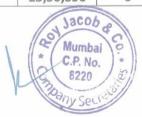
