Pursuant to Regulation 30 of Listing Regulations, we hereby inform that the Board of Directors of Somany Ceramics Limited ("Company"), in its meeting held on 15th January, 2025 has decided to sell the Company's equity stake in Acer Granito Private Limited ("AGPL"), an associate company of the Company. The Company is holding 26.05% of the total paid-up capital of AGPL and it has decided to sell its entire stake/investment in the equity shares of AGPL ("Proposed Transaction").

Consequently, AGPL will cease to be the Company's associate company after the disinvestment.

The meeting of Board of Directors was commenced at 12:15 p.m. and concluded at 01:45 p.m.
