In compliance with the requirements of applicable circulars issued by the Ministry of Corporate Affairs ("MCA"), Government of India and SEBI, Company has e-mailed the Notice of 54th AGM along with the Annual Report 2023/24 to those Members whose email addresses are registered with the Company/Depository Participant.

Members holding shares in physical form or in dematerialized form may cast their vote electronically on the Business Items, as set out in the Notice of AGM. Members, who have exercised their vote by Remote E-voting, may also attend the AGM but shall not be allowed to vote again at the meeting.

Cut-off date for the purpose of E-voting is Friday, 02nd August, 2024 and a person, whose name is recorded in the register of members or in the register of beneficial owners maintained by the depositories as on cut-off date, shall only be entitled to avail the facility of Remote E-voting during the AGM.

The Remote E-voting facility shall commence on Tuesday, 06th August, 2024 at 9:00 a.m. and shall end on Thursday, 08th August, 2024, 5:00 p.m. E-voting portal shall be blocked after the aforesaid date and time for voting.

Any person who acquires shares after dispatch of Notice of AGM and holding shares as on the cut-off date, may obtain the required login ID and password by sending a request at helpdesk.evoting@cdslindia.com.
