Pursuant to Regulation 30 of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 read with Para B of Part A of Schedule III of the Regulations, this is to inform you that the Board of Directors of the Company in its meeting held today i.e. 28<sup>th</sup> November, 2024, has approved to increase the processed fabric capacity at Vardhman Fabrics, Budhni, Madhya Pradesh by about 31 million meters p.a. with a total capital outlay of Rs. 350 crore (approx.).

The details of the proposed capacity enhancement, as required under SEBI Circular no. SEBI/HO/CFD/CFD-PoD-1/P/CIR/2023/123 dated 13<sup>th</sup> July, 2023 are as follows:

1. Existing capacity	About 175 million meter p.a. of processed fabric.
2. Existing Capacity Utilization	Above 90%.
3. Proposed Capacity Addition	About 31 million meter per annum
4.Period within which proposed capacity	Within two years
is to be added	
5. Investment Required	Rs. 350 crore (approx.)
6. Mode of financing	From internal accruals/ debt
7. Rationale	To meet increasing demand of processed fabric
*	in both export and domestic markets.
