

1. We, S K Patodia & Associates LLP, Chartered Accountants ("we" or "us") have reviewed the accompanying Statement of Unaudited Financial Results of NDL Ventures Limited (formerly known as NXTDIGITAL Limited) ("the Company") for the quarter ended September 30, 2024 and year to date results for the period April 01, 2024 to September 30, 2024, which are included in the accompanying 'Statement of unaudited financial results for the quarter and half year ended September 30, 2024', the statement of unaudited assets and liabilities as on that date and the statement of unaudited cash flows for the half-year ended on that date (the "Statement").
