Associated Ceramics Limited has provided E-Voting facility through NSDL to its shareholders for exercising their right to vote on the resolutions set in the Notice of AGM to be held on 30th September, 2024 at 3:00 p.m. The members may cast their votes using electronic voting system through NSDL from any place ('remote e-voting'). The details pursuant to the provisions of the Companies Act, 2013 and the Rules, are given here under:

- i. Date of completion of sending of Notices of AGM : 06.09.2024
- ii. Date and time of commencement of "Remote e-voting": Friday, 27th September, 2024 at 9:00 A.M.
- iii. Date and time of end of "Remote e-voting" : Sunday, 29th September, 2024 at 5:00 P.M.(same day)
- iv. Cut-off date for E-Voting : Monday, 23rd day of September, 2024
- v. Remote E-voting shall not be allowed beyond 5:00 P.M. on Sunday, 29th September, 2024.
- vi. Any person, who acquires shares of the Company and become member of the Company after dispatch of the notice and holding shares as of the cut-off date i.e. 23rd day of September, 2024, may obtain the login ID and password by sending a request at evoting@nsdl.com or assockd@rediffmail.com . However, if you are already registered with NSDL for remote e-voting then you can use your existing user ID and password for casting your vote. If you forgot your password, you can reset your password by using "Forgot User Details / Password" option available on www.evoting.nsdl.com or contact NSDL at the following toll free no.: 022 - 4886 7000.
- vii. The members who have casted their vote by remote e-voting prior to the AGM may also attend the AGM but shall not be entitled to cast their vote again.


