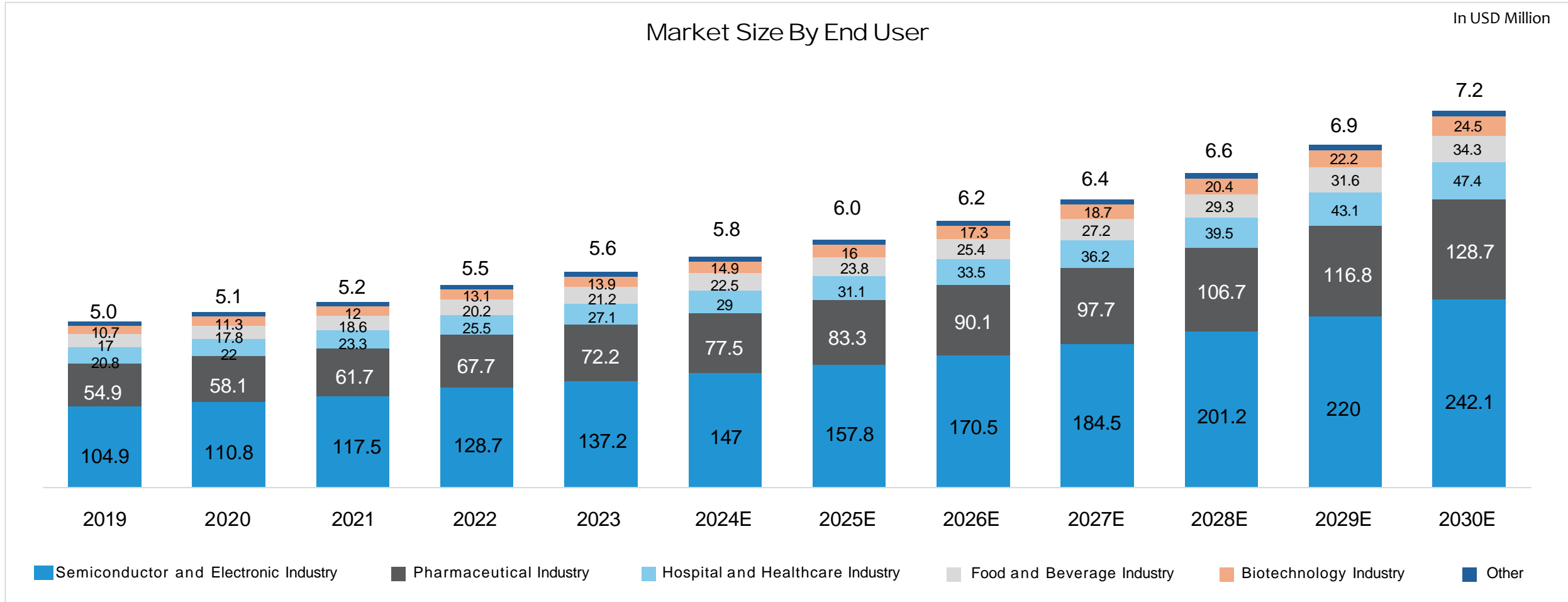
Market Size & Material Trends In Indian Cleanroom Technologies

Market Size By End User & By Region

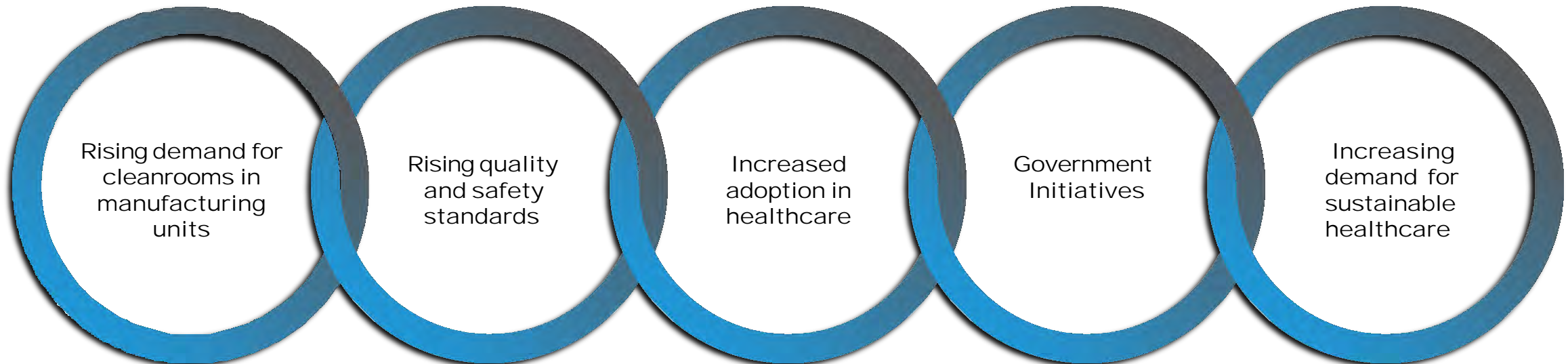

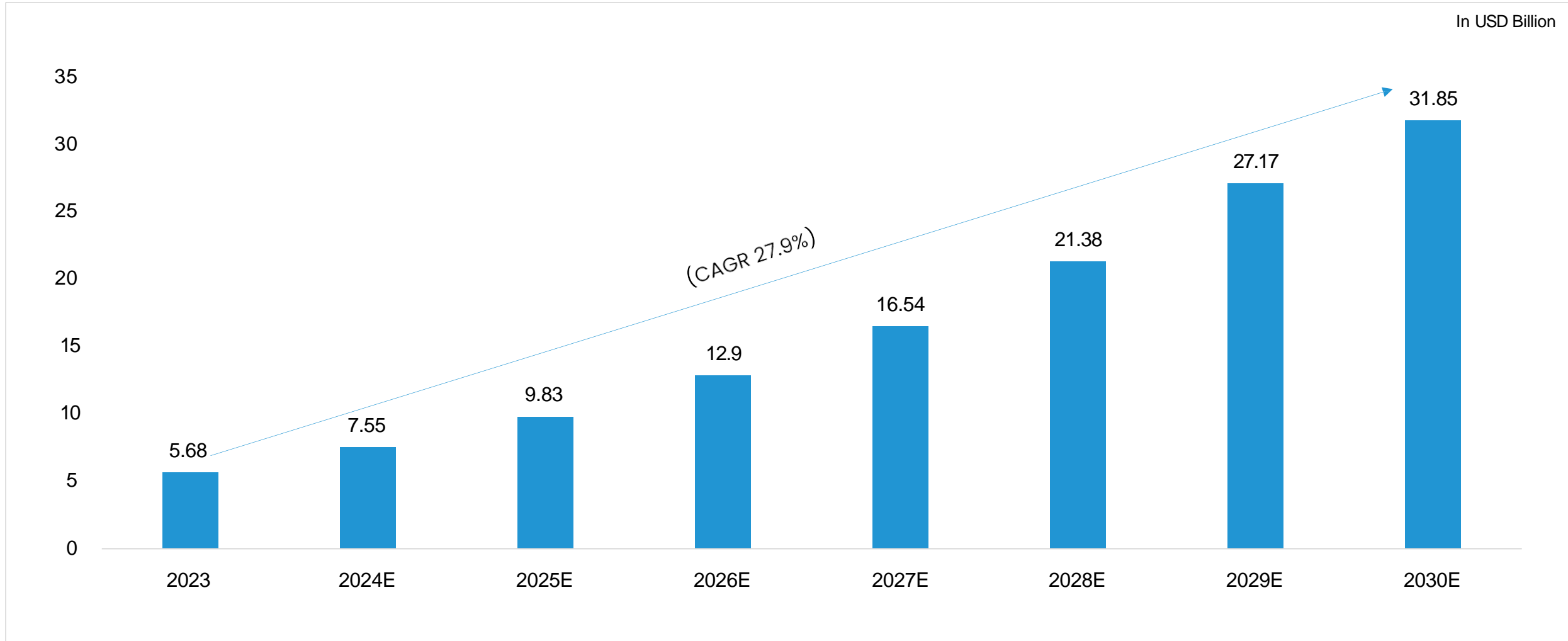

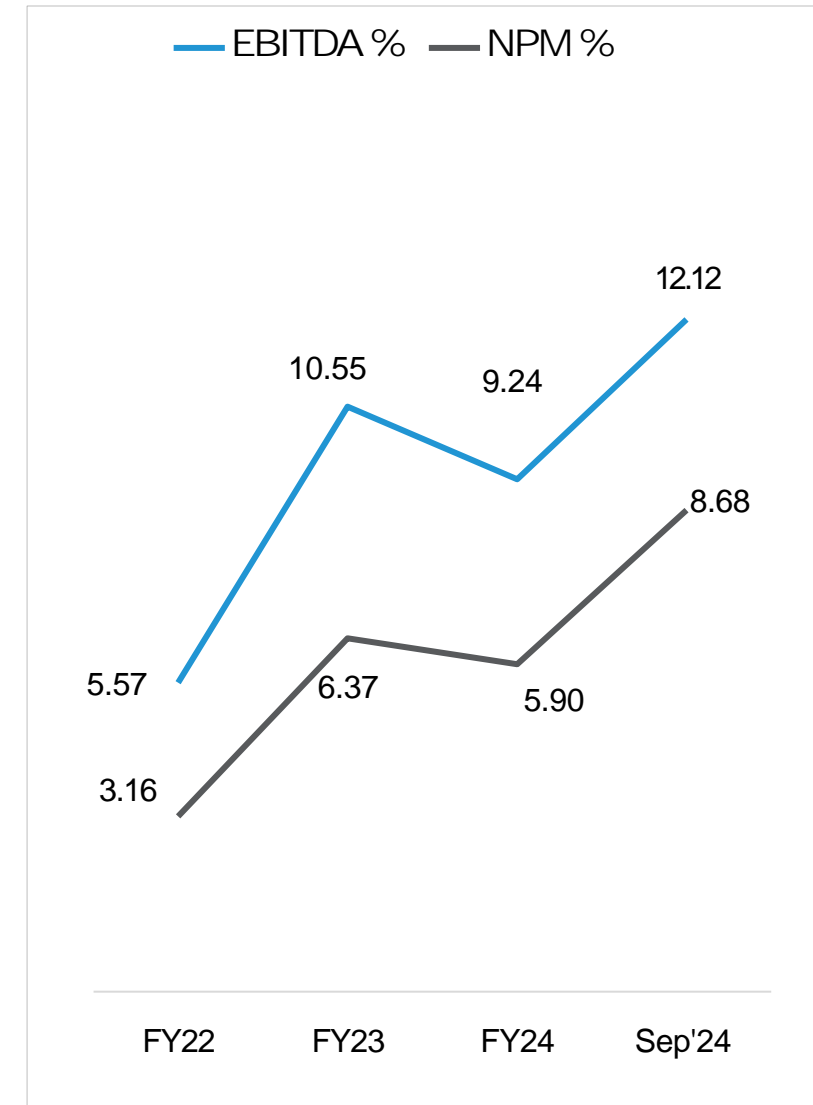
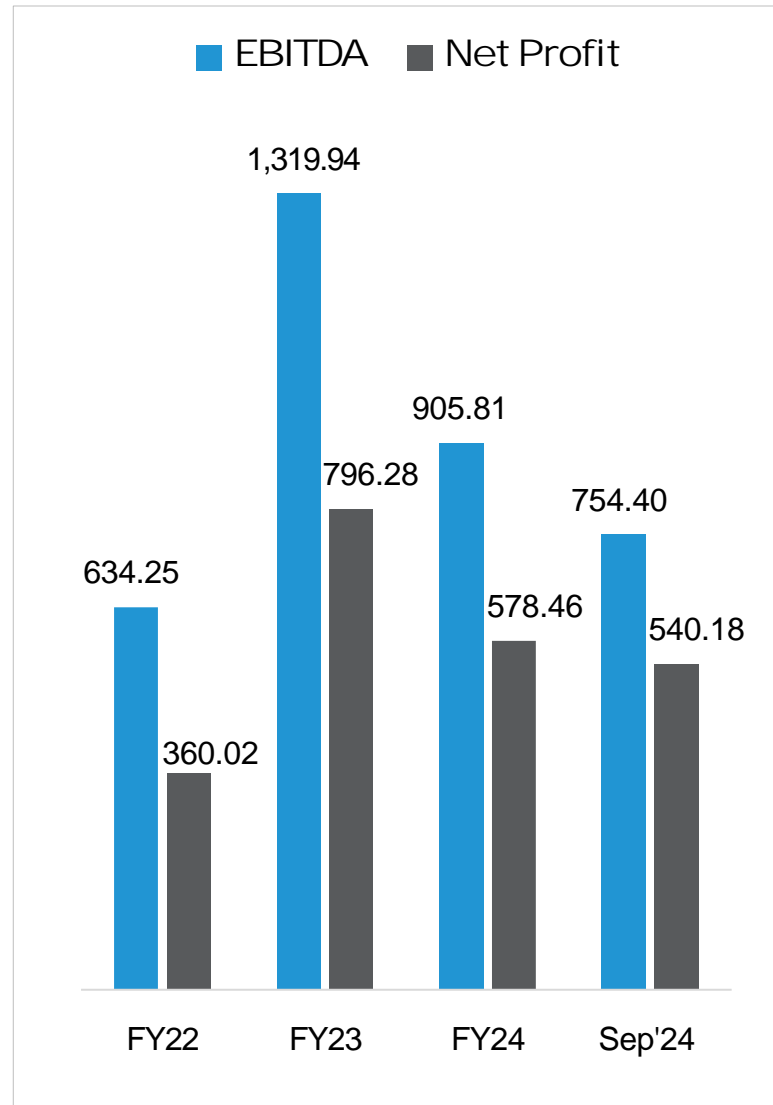
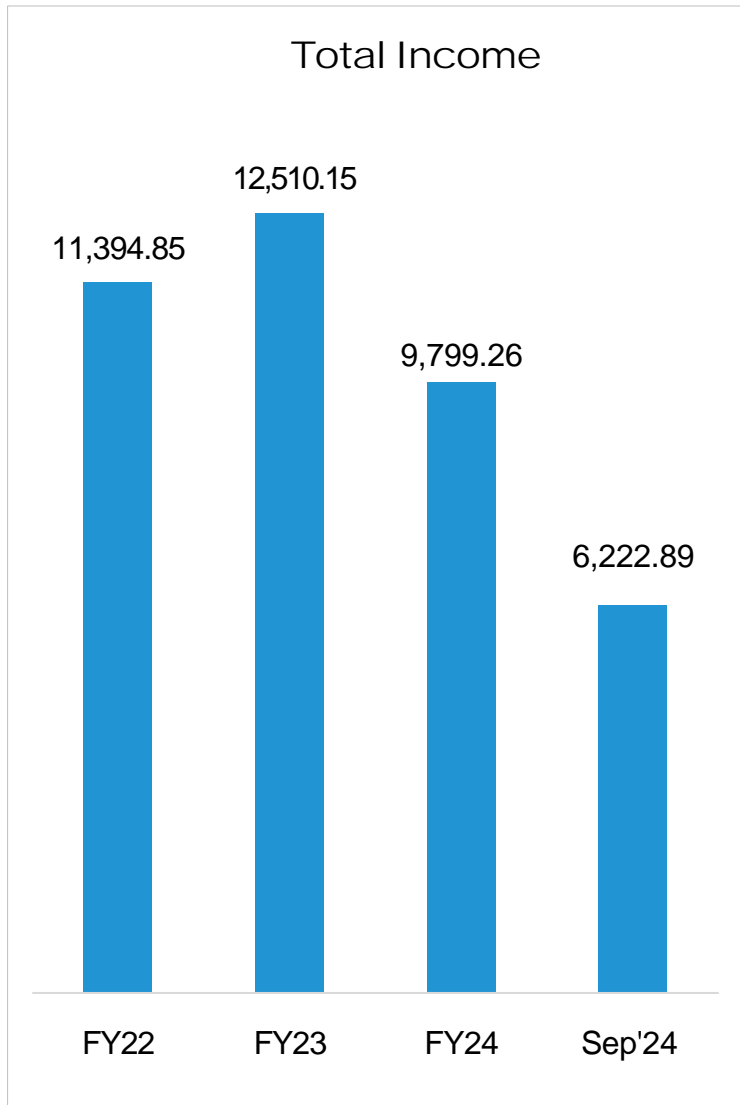


Indian HVAC Market Size, By Value



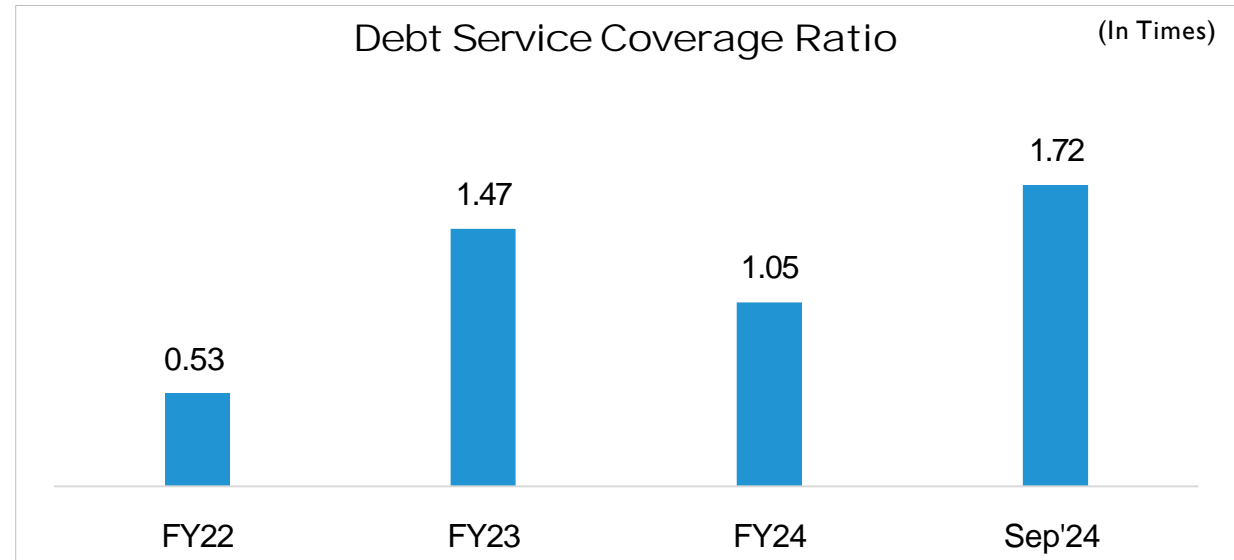
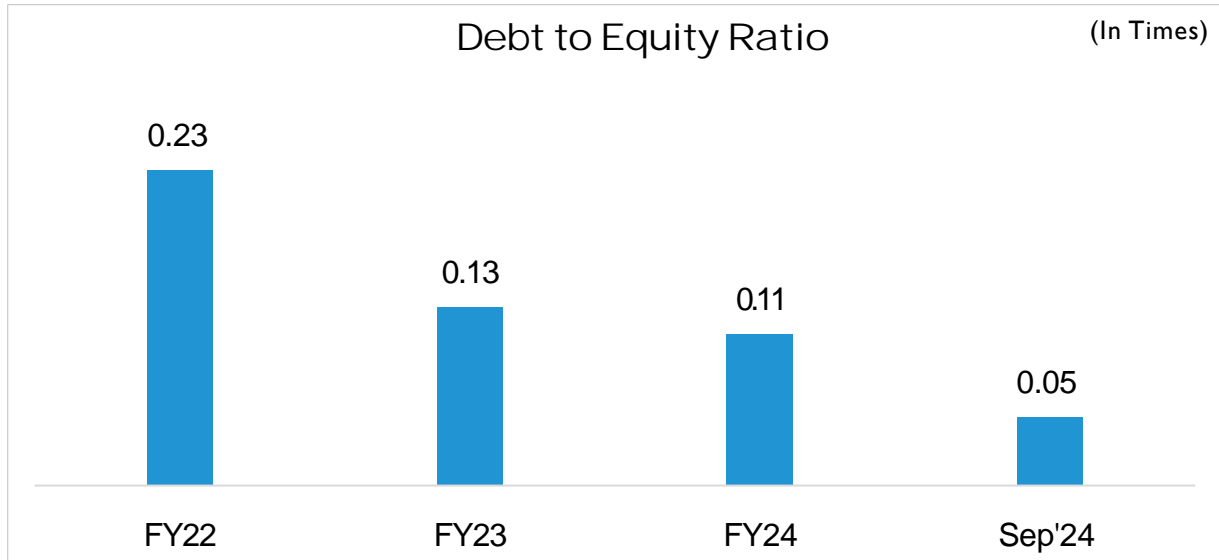
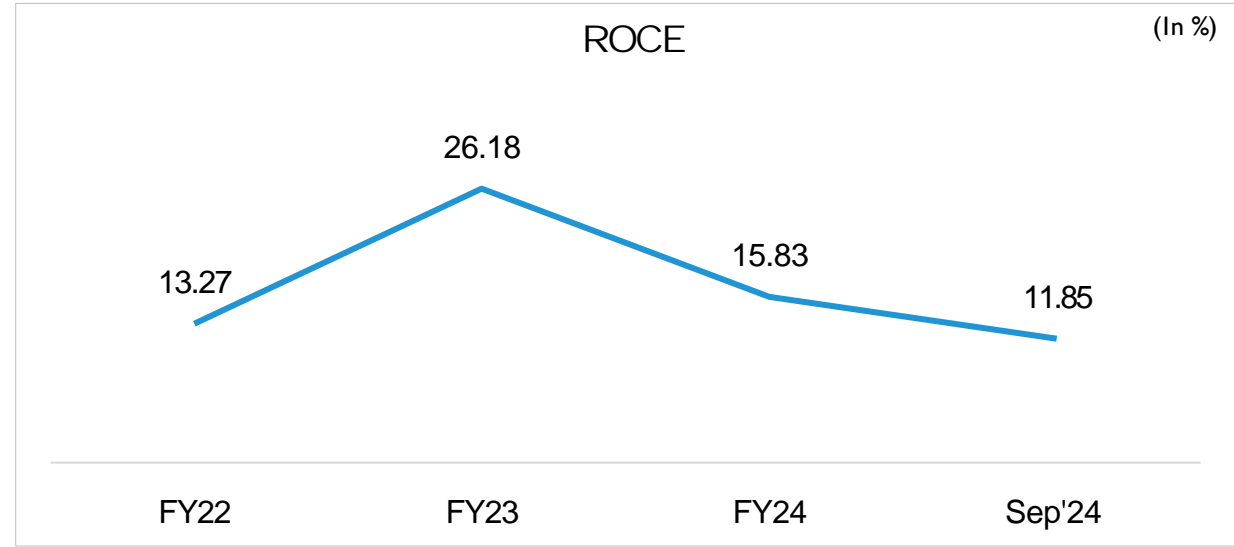
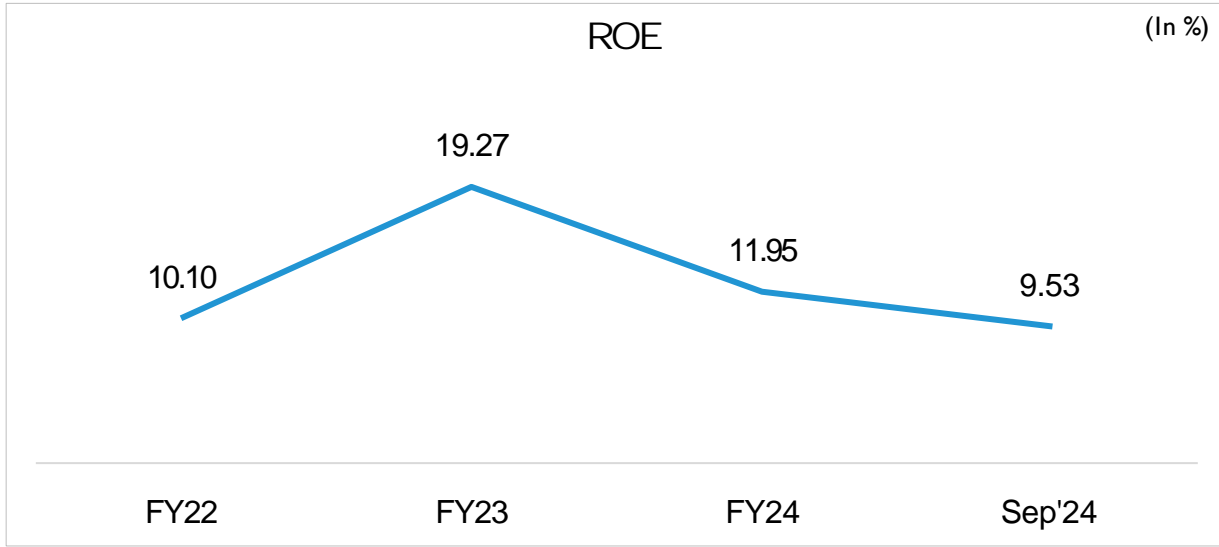

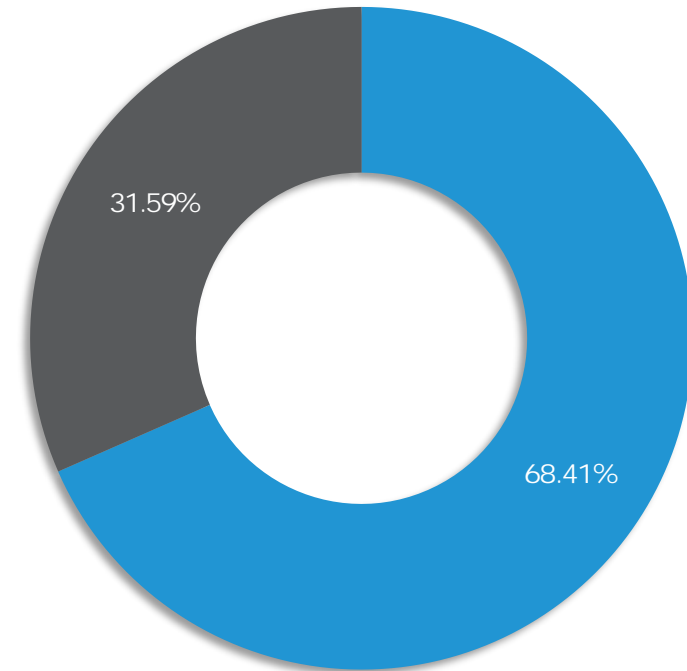
