With reference to the captioned subject, we would like to inform you that the Company has received an order from the office of the Assistant Commissioner of GST & Central Excise, Marai, Malai Nagar Division, Tamil Nadu for the financial year 2019-20, imposing demand of ₹ 86,83,673 /- (Tax ₹ 43,42,639/-, Interest ₹ 39,06,771/- and Penalty of ₹4,34,263) under Goods and Services Tax Act, 2017.

Based on the merits of the matter, prevailing law and advice of the consultant, the Company is planning to appeal against this order before the Commissioner (Appeals) and reasonably expects favourable orders from the appellant authorities.
