## Bharatanatyam by NRI Tamils at Thanjai Periya Kovil tomorrow

Chennai, July 30: Radhika, known for her "Paattukku Paattu" fame, and Deepa, both London-based Tamils, jointly run the Rhythm Sangeetha Academy, a dance and music school.

On behalf of this academy, a Bharatanatyam performance, a traditional dance of Tamil Nadu, will be held at the Thanjai Periya Kovil on July 31. Following this, the group will conduct a Bharatanatyam performance at the Madurai Meenakshi Amman Temple on August 3.

For this purpose, 52 Bharatanatyam dance students have been brought from London. All 52 students are native Tamils from London and its surrounding provinces. According to Radhika from

Rhythm Sangeetha Academy, the goal is not only to perform Bharatanatyam at the Thanjai Periya Kovil and Madurai Meenakshi Amman Temple but also to introduce this art form to other London-based Tamils.

Regarding this, Radhika addressed the media in performance, a traditional dance of Tamil Nadu, stating that many people mentioned organizing this event would be difficult. However, when she approached the Tamil Nadu government formally, the officials granted the necessary permission.

She noted that while their group has performed in European countries like Germany and Ukraine, the Bharatanatyam performance



they conducted at the Chidambaram Temple in Tamil Nadu gave them the most significant recognition. Additionally, she mentioned that their group's 20th-anniversary

celebration would involve dedicating their dance performances to the deities at Thanjai Periya Kovil and Madurai Meenakshi Amman Temple in Tamil Nadu.
