6. During the financial year 2022-23, The Trade Payables of the Company included a vendor having outstanding for more than 3 years amount of Rs. 49.32 lakhs as at March 31, 2023. The vendor was under Corporate Insolvency Resolution Process from January 2018. The management of the Company was making all the efforts to quantify the amount payable to the vendor However, the company has not received any claim. Hence, in the opinion of management, it is Witten back in the books of account: during the year in absence of the confirmation of the vendor.

7. During the quarter, the company has made the provision of Doubtful Debts of Trade Receivable amount of Rs. 276.65 lakhs ir the books of account. However, Management is of the view that it will be able to monitor effectively the deficit in future and recove the dues from debtors

8. The figures for the quarter ended 31/03/2024 & 31/03/2023 are the balancing figures between the audited figures in respect of the full financial year 2023-24 and 2022-23 and the published unaudited year to date figures up to the third quarter ended 31/12/2023 & 31/12/2023 respectively.

9. Other Income includes gain / (Loss) on sale of Shares and Mutual Funds of Rs. (0.02) Lakhs and Rs. 27.14 Lakhs for the quarte and year ended 31st March 2024 (Quarter and year ended 31st March 2023: Rs. 11.73 Lakhs and Rs. 38.66 Lakhs Respectively).

10. In the current Financial Year, there was a change in management of the company through an Open Offer method through the SAST Guidelines of SEBI. This process of takeover and change in management took more than 4 working months and hence sales of the Company have been affected adversely.

11. The Statutory Auditors of the Company have conducted audit of the financial results for the year ended 31/03/2024 pursuant to the requirement of Regulation 33 of the SEBI (LODR) Regulations, 2015 and have given an qualified opinion in their report.

12. The standalone financial results for the year ended 31/03/2024 have been extracted from the audited standalone financia statements prepared in accordance with the Indian Accounting Standards (Ind-AS) as prescribed under Section 133 of the Companies Act, 2013 read with Rule 3 of the Companies (Indian Accounting Standards) Rules, 2015 and relevant amendment rules issued thereafter.
