Pursuant to Regulation 30 of the SEBI (Listing Obligation and Disclosure Requirements Regulation 2015 and our intimation for Resignation of Statutory Auditor dated 6th January, 2025, we wish to inform you that we forgot to attach the Resignation letter of Statutory Auditor in previous announcement inadvertently. The copy of Resignation Letter dated 30.12.2024 and Details in respect to resignation of auditors of the company as required under Regulation 30 Read with Schedule III of the Listing Regulations. SEBI Circular CIR/CFD/CMD/4/2015 dated September 09, 2015 and CIR/CFD/CMD/114/2019 dated October 18,2019 are annexed herewith as Annexure: I.

NOTE:

M/s. Panchal S K & Associates, Chartered Accountants (FRN No. 145989W), Statutory Auditor of the Company have tendered their resignation vide their letter dated: 30.12.2024 informing their inability to continue as the statutory Auditors of the Company. Firstly, we received an email regarding the resignation of the auditor on 30th December, 2024 but the details required under Regulation 30 of SEBI LODR Regulations received from an Auditor on 4th January, 2025, after taking multiple follow-ups. As per SEBI Circular CIR/CFD/CMD1/114/2019 dated 18th October, 2019, If the auditor resigns after 45 days from the end of a quarter, they must issue the limited review or audit report for the current and next quarters before resigning. But the Statutory auditor refused to issue limited review report for the quarter ended 31st December, 2024.

Dear Sir/Madam,

We, Panchal S K Associates, Chartered Accountant (Firm Registration No. 145989W) were appointed as the Statutory Auditors of the Company to perform the audit of financial statements of the Company for a period of 5 consecutive years beginning from F.Y. 2024-2025 to 2028-2029.

We are considering the recent SEBI Interim Order cum Show Cause Notice No. WTM/AB/CFID/CFID-SEC3/31030/2024-25, raising concerns about the Company's financial conduct. Given the gravity of the situation and the regulatory scrutiny the Company is currently facing, we have carefully considered our position and have come to the conclusion that it is no longer tenable for us to continue as Statutory Auditors of the Company.

Professional Integrity and Legal Compliance: As our firm committed to the highest standards of professional ethics, legal compliance, and independence, we have always strived to carry out our duties in accordance with the **Companies Act, 2013** and other applicable laws. However, due to the circumstances and the regulatory concerns surrounding the Company, we believe that continuing in the role of Statutory Auditor would compromise our professional integrity and responsibilities, and we would no longer be able to uphold the ethical standards expected under the Companies Act, 2013 and other relevant laws.

In view of the above, we express our inability to continue as the Statutory Auditor of the Company.

Please accept our resignation with immediate effect from 30th December, 2024.

As required under the Companies Act, 2013, we will be filing Form ADT-3 with the Registrar of Companies (ROC) to formally notify our resignation. We will ensure that the filing is completed within the prescribed time frame of 30 days from the date of this resignation.
