## 42<sup>nd</sup> ANNUAL GENERAL MEETING HELD ON 24<sup>th</sup> JULY 2024 Declaration of Results of E-voting and Poll

As per the provisions of the Companies Act 2013 and as per SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, the company had provided the facility of remote e-voting to the shareholders to enable them to cast their vote electronically on the resolutions proposed in the notice of the 42<sup>nd</sup> Annual General Meeting. The e-voting was opened from 21<sup>st</sup> July, 2024 and ended on 23<sup>rd</sup> July, 2024.

In line with the Companies Act 2013 and applicable rules, voting by show of hands was not permitted at the Annual General Meeting where evoting has been offered to the shareholders. Therefore at the 42<sup>nd</sup> Annual General Meeting voting was conducted by means of Poll.

The Board of Directors has appointed Mr. Sahib Chauhan, Chartered Accountant as scrutinizer for e-voting and poll. The scrutinizer has carried out the scrutiny of all the electronic votes received up to the close of working hours on 23<sup>rd</sup> July, 2024 and physical votes on the date of AGM held on 24<sup>th</sup> July, 2024 and submitted his report on 25<sup>th</sup> July, 2024.
