In compliance with Regulation 44 of the Listing Regulations and pursuant to the provisions of Sections 108 and 110 of the Act read with the Rules, the MCA Circulars and SS-2, the Company is providing remote e-voting facility to its members to enable them to cast their votes electronically instead of submitting the Postal Ballot Form physically. The Company has engaged the services of KFin Technologies Limited ('**KFinTech / RTA**') for the purpose of providing remote e-voting facility to its members. The Results declared along with the Scrutinizer's Report shall be placed on the Company's website <u>www.gnfc.in</u> and on the website of KFinTech <u>https://evoting.kfintech.com</u> immediately after the result is declared by the Chairman or any other person authorized by him, and the same shall be communicated to the Stock Exchanges, where the Equity Shares of the Company are listed.
