Sub: Report of the Scrutinizer for e-voting Process conducted vide Notice Dated 13th August 2024 under Section 108 of the Companies Act, 2013 read with Companies (Management and Administration) Rules, 2014 in respect of the 49th Annual General Meeting of National Oxygen Limited ('the Company').

In the meeting of the Board of Directors of National Oxygen Limited held on 13th August 2024, I, Mrs. Lakshmi Subramanian, Practicing Company Secretary, was appointed as Scrutinizer for process of voting through electronic means ("e-voting") issued in accordance with General Circular No. 14/2020 dated April 8, 2020 and MCA Circular No. 17/2020 dated April 13, 2020, MCA Circular No. 20/2021 dated May 05, 2020, Circular No. 02/2021 dated January 13, 2021 an General Circular No. 21/2021 dated 14.12.2021, No. 2/2022 dated May 5, 2022 and No. 10/2022 dated December 28, 2022, No.09/2023 dated September 25, 2023 issued by the Ministry of Corporate Affairs (MCA) (hereinafter referred to as "MCA Circulars"), Government of India, hereby calling the 49th Annual General Meeting of its Equity Shareholders ("the Meeting" /"AGM") through VC / OAVM. The AGM was convened on Monday, 16th September, 2024 at 11.30 AM through VC / OAVM as per section 108 of the Companies Act, 2013 ('Cos Act') for passing of the items of Ordinary business and Special business as Ordinary resolutions and Special Resolutions by the members of the Company:

The Company has availed the e-voting facility from Central Depository Services (India) Limited for the shareholders to cast their votes to the aforesaid resolutions through electronic mode. Section 108 of the Companies Act, 2013 read with Companies (Management and Administration) Rules, 2014 recognizes voting by electronic mode, which is prescribed as the appropriate mechanism for e-Voting.

- The e-voting commenced on Friday, 13th September 2024 (09.00 hours IST) and was open
  up to the close of working hours Sunday, 15th of September 2024 (17.00 hours IST) and
  the e-voting at the time of the AGM commenced on 16th September 2024 from 11:51 AM to
  12.06 PM (15 minutes time was provided for e-voting after the conclusion of the meeting
  at 11.51 AM)
- All electronic votes received up to the close of working hours at 17.00 hours IST on 15th September, 2024 and received at the time of the Annual General Meeting were considered for my scrutiny.
- Details of the votes cast by the members through electronic voting system was downloaded and collected from the website <u>www.evotingindia.com</u> was sent by the RTA on 16th September, 2024.
- A register containing the details of assent or dissent, received, mentioning the particulars
