However, due to oversight mistake, the "Current Tax Liabilities (Net)" as reported earlier under the head of Current Liabilities in the Statement of Assets and Liabilities for the period ended March 31, 2024 was overstated by \$ 00.23 Lakhs and due to same, the amount of "Other Equity" was understated by \$ 00.23 Lakhs. There is no impact on the Profit before tax for the quarter ended and for the period ended March 31, 2024 and had also no impacted the reported Earnings per Share (EPS) of the Company. There is no change in the cash flows for the period as reported by the Company.

We would like to further inform that it was a clerical error which was unintentional and not deliberate. You are kindly requested to accept this and take into the records. We will be more careful in future.

To ensure accuracy and transparency, we are hereby submitting revised financial results for your examination. We apologize for any inconvenience this may have caused and assure you that we have implemented measures to prevent such errors in the future.
