Sub.-: Updating material developments with respect to the fire incident occurred on 24th November, 2024

In continuation to our letter dated 24th November, 2024 having reference no. GLOBALE/CS/Correspondence/2024-25/19, pursuant to Regulation 30 read with Schedule III of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015, we had already informed your good self that fire had occurred at Mahalaxmi Fabric Mills Limited (MFML) Plant located at Isanpur Road, Nr. Narol Char Rasta, Narol, Ahmedabad – 382 405, Gujarat, on 24th November, 2024, at around 8:30 a.m. (IST). We would like to provide an update on the measures undertaken to restore the supply levels.

Further, we have been informed by MFML that Stocks of our Company were lying at the said Plant for processing and it has been partially damaged in fire.

Due to the said fire incident, the MFML's Plant and Machinery, Buildings and Stocks have been damaged. MFML is in the process of ascertaining the actual loss caused by it. Production operation of the said Plant has continued to be disrupted. MFML is working diligently to further scale up operations, leveraging all available resources to ensure that production and supply levels are re-instated to the maximum as soon as possible.

We will keep you informed of any significant developments. Thank you for your attention and understanding. Kindly take the same on record and oblige.
