**Salary:** Not Exceeding INR 1,100,000/- (Rupees Eleven Lakhs only) per month

**Allowances:** Not Exceeding INR 600,000/- (Rupees Six Lakhs only) per month.

With increments as per the Company’s Policy and as may be determined by the Board of Directors, from time to time, subject to a ceiling on increment of 30% in a year over the existing Salary and Allowance.
