Sub: Grant of Stock Options under Employees Stock Option Scheme – 2020

Pursuant to the provisions of Regulation 30 of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 and other applicable circulars, we wish to inform you that in terms of the approval granted by the Shareholders of the Company at the Annual General Meeting held on July 25, 2024, the Nomination & Remuneration Committee ('NRC') of the Board of Directors of the Company at its meeting held today i.e. on January 14, 2025 has approved the grant of 7,500 stock options representing 7,500 equity shares of Rs. 5/- each to the eligible employees of the Company and Wholly Owned Subsidiary of the Company, under Employees Stock Option Scheme – 2020 (ESOS – 2020) at grant price of Rs. 3,834.55 per option.

Details of stock options granted are provided below:

a.	Brief details of options granted	As determined by the NRC, 7,500 stock options granted to eligible employees of the Company and and Wholly Owned Subsidiary of the Company, viz. "HDFC AMC International (IFSC) Limited" ("WOS"). Each option upon exercise would be entitled for allotment of one equity share of Rs. 5/- each of the Company.

е.	Options vested	NRC. Subject to the fulfilment of the conditions as specified in ESOS – 2020, the options shall vest in three tranches. 1st tranche - 1/3rd of the options granted shall vest on the completion of 1 (one) year from the date of grant; 2nd tranche - 1/3rd of the options granted shall vest on the completion of 2 (two) years from the date of grant; 3rd tranche - balance 1/3rd of the options shall vest on the completion of 3 (three) years from the date of grant.
f.	Time within which options may be exercised	All the vested options will have to be exercised by the eligible employees within 5 (five) years from the date of respective vesting.
